CITY OF TORONTO

BY-LAW No. 224-2011

To amend City of Toronto Municipal Code Chapter 545, Licensing, respecting business licensing fees.

WHEREAS the *City of Toronto Act, 2006* grants the City of Toronto the authority to enact by-laws for the licensing, regulating and governing of businesses wholly or partly carried on in the City of Toronto, including the ability to require the payment of licence fees; and

WHEREAS setting licence fees that are sufficient to cover the costs of the administration and enforcement of Chapter 545 is necessary to ensure the protection of consumers, the health and safety of the public and the control of nuisances can be accomplished through an adequately funded and administratively efficient program; and

WHEREAS, due to a federal directive changing the use and disclosure of Criminal Record Information, Municipal Licensing and Standards no longer conducts the indirect collection of criminal record information and requires clients to obtain their own police clearance searches; and

WHEREAS this change in practice will result in a fee reduction of \$25.00 for all licence applications, as of January 1, 2011;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Appendix A to Toronto Municipal Code Chapter 545, Licensing, is amended by deleting the dollar amounts listed under each Fee Class and replacing them with the following amounts:
