BY-LAW No. 256-2011

**To amend By-law No. 2958-94 of the former City of York, being a By-law
"To regulate traffic on City of York Roads", regarding Corby Avenue, Earnscliffe Road,
Glenhurst Avenue, Holland Park Avenue and McRoberts Avenue.**

The Etobicoke York Community Council HEREBY ENACTS as follows:

1. That Schedule VIII (No Parking) of former City of York By-law No. 2958-94, as amended, be further amended by deleting from Columns 1, 2, 3 and 4 of the said Schedule the following:

Corby Avenue	North	Gilbert Avenue and McRoberts Avenue	1st and 3rd Wed. of each month, Apr. 1st to Nov. 30th, inclusive
Corby Avenue	South	Gilbert Avenue and McRoberts Avenue	Anytime except the 1st and 3rd Wed. of each month, Apr. 1st to Nov. 30th, inclusive
Earnscliffe Road	North	Glenholme Avenue and Oakwood Avenue	Anytime, except the 1st and 3rd Wednesday of each month, April 1st to November 30th, inclusive
Earnscliffe Road	South	Glenholme Avenue and Oakwood Avenue	1st and 3rd Wednesday of each month, April 1st to November 30th, inclusive

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times or days)
Glenhurst Avenue	North	The westerly terminus street and Crang Avenue	Anytime, except the 1st and 3rd Wednesday of each month, April 1st to November 30th, inclusive
Glenhurst Avenue	South	The westerly terminus street and Crang Avenue	1st and 3rd Wednesday of each month, April 1st to November 30th, inclusive
Holland Park Avenue	North	Oakwood Avenue and Winona Drive	Anytime, except the 1st and 3rd Wednesday of each month, April 1st to November 30th, inclusive
Holland Park Avenue	South	Oakwood Avenue and Winona Drive	1st and 3rd Wednesday of each month, April 1st to November 30th, inclusive
McRoberts Avenue	East	A point 76.3 metres south of Rogers Road and Rogers Road	Anytime, except the 1st and 3rd Wednesday of each month, April 1st to November 30th, inclusive
McRoberts Avenue	West	A point 76.3 metres south of Rogers Road and Rogers Road	1st and 3rd Wednesday of each month, April 1st to November 30th, inclusive
