## BY-LAW No. 302-2011

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Carlton Street, Clinton Street, Hallam Street, Kenneth Avenue, Kingswood Road, Patricia Drive, Pauline Avenue, Sackville Street and St. Clarens Avenue.

The Toronto and East York Community Council HEREBY ENACTS as follows:

- **1.** Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:
