The Official Plan of the City of Toronto is amended as follows:


1. Chapter 6, Section 29, Sheppard Avenue Commercial Area Secondary Plan is amended by adding the following subsection to Section 4.0, Site and Area Specific Policies:

"4.6 Lands located on the north side of Sheppard Avenue West, municipally known as 110 Sheppard Avenue West (6 on Map 29-1):

A maximum building height of 3 storeys and 11.0 metres, and a maximum F.S.I. of 1.1 are permitted. The policies of Section 3.2.2 do not apply."

2. Map 29-1, Land Use Areas of the Sheppard Avenue Commercial Area Secondary Plan, is amended to show the lands municipally known in 2011 as 110 Sheppard Avenue West (Lot 26 and Part of Lot 27, Registered Plan M-389) as Site and Area Specific Policy Area Number 6, as shown on the attached Schedule A.
