BY-LAW No. 519-2011

To amend City of Toronto Municipal Code Chapter 217, Records, Corporate (City), by amending records series.

WHEREAS under section 201 of the *City of Toronto Act*, 2006 the City may, subject to the approval of the City auditor, establish retention periods during which the records of the City and local boards of the City must be retained and preserved; and

WHEREAS the City's external auditor is currently the "City auditor" for the purposes of subsection 201(3) of the City of Toronto Act, 2006; and

WHEREAS the City's external auditor has approved the amended and new retention periods as set out in this by-law; and

WHEREAS under § 169-26B Council has authorized the City Solicitor in consultation with the City Clerk to introduce bills to Council to make technical amendments to the Municipal Code and other by-laws, including legislation updates; and

WHEREAS the records record series for code "A0532" with the record title "Property Management" was approved by Council (as set out in Administration Committee Report 6, Clause 19, "Records Retention By-law Amendment", as adopted by City of Toronto Council on September 25, 26 and 27, 2006, and as confirmed by By-law No. 1076-2006, "To confirm the proceedings of the Council at its meeting held on the 25th, 26th and 27th days of September, 2006") and should also be included in Chapter 217;

The Council of the City of Toronto HEREBY ENACTS as follows:

- **1.** Schedule A to Article II of Chapter 217, Records, Corporate (City), of The City of Toronto Municipal Code is amended as follows:
