BY-LAW No. 579-2011

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Grenville Street and Grosvenor Street.

The Toronto and East York Community Council HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By deleting from Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

Grenville Street	North	A point 43.5 metres west of Bay Street and a point 76.2 metres west of Bay Street	Anytime

B. By deleting from Schedule XXIV (No Stopping) in § 400-77, the following in alphabetical order by street name:

Grosvenor Street	North	A point 70 metres west of Bay Street and a point 20 metres further west	Anytime

C. By inserting in Schedule XXIV (No Stopping) in § 400-77, the following in alphabetical order by street name:

Grenville Street	North	A point 43.5 metres west of Bay Street and a point 79.6 metres west of Bay Street	Anytime
Grosvenor Street	North	A point 57.3 metres west of Bay Street and a point 99.8 metres west of Bay Street	Anytime
Grosvenor Street	South	A point 47.3 metres west of Bay Street and a point 89.8 metres west of Bay Street	Anytime

D. By deleting from Schedule XXV (Time Limit Parking) in § 400-78, the following in alphabetical order by street name:

Grenville Street	North	Surrey Place and Bay Street	8:00 a.m. to 6:00 p.m.	60 mins.
Grosvenor Street	North	Queen's Park Crescent (east branch) and a point 57.3 metres west of Bay Street	8:00 a.m. to 6:00 p.m. Mon. to Sat.	2 hours

E. By deleting from Schedule XXIX (No Standing) in § 400-82, the following in alphabetical order by street name:

Grosvenor Street	South	Surrey Place and a point 47.3 metres west of Bay Street	Anytime

F. By inserting in Schedule XXIX (No Standing) in § 400-82, the following in alphabetical order by street name:

Grosvenor Street	South	Surrey Place and a point 89.8 metres west of Bay Street	Anytime

2. This By-law shall be effective commencing April 22, 2011.
