BY-LAW No. 860-2011

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Essex Street.

The Toronto and East York Community Council HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By deleting from Schedule XI (School Bus Loading Zones) in § 400-64, the following in alphabetical order by street name:

Essex Street

North side, between a point 101.5 metres west of Christie Street and a point 65.5 metres further west

Essex Street

North side, between a point 284 metres west of Christie Street and a point 67 metres further west
