BY-LAW No. 870-2011

To amend City of Toronto Municipal Code Chapter 903, Parking for Persons with Disabilities, respecting Bank Street, Lesmount Avenue, Manning Avenue, Monarch Park Avenue, Norwood Road, Palmerston Avenue and Woodmount Avenue.

The Toronto and East York Community Council HEREBY ENACTS as follows:

- **1.** Municipal Code Chapter 903, Parking for Persons with Disabilities, of the City of Toronto is amended as follows:
- A. By deleting from Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:
