## **CITY OF TORONTO**

### **BY-LAW No. 1038-2011**

**To amend By-law No. 31001 of the former City of North York, respecting the regulation of traffic on North York roads, regarding Rean Drive.**

The North York Community Council HEREBY ENACTS as follows:

1. Schedule "VIII" (No Parking) of By-law No. 31001, of the former City of North York, is amended by deleting from Columns 1, 2, 3 and 4 the following:
