BY-LAW No. 1084-2011

To amend further By-law No. 92-93, a by-law "To regulate traffic on roads in the Borough of East York", being a by-law of the former Borough of East York, regarding Cedarcrest Boulevard and Gower Street.

The Toronto and East York Community Council HEREBY ENACTS as follows:

1. Schedule VIII (No Parking) of By-law No. 92-93, as amended, being a by-law of the former Borough of East York, is hereby further amended by striking out the following words and figures where they occur opposite each other in Columns 1, 2, 3 and 4 of the said Schedule:

(From Column 1 Road)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and Days)
Cedarcrest Boulevard	East	Gower Street and a point 73 metres north of Gower Street	8:30 a.m. to 4:30 p.m. Monday to Friday inclusive
Cedarcrest Boulevard	West	Adjacent to George Webster School grounds	Anytime
Gowar Street	North	Cedarcrest Boulevard and a point 30.5 metres east of Cedarcrest Boulevard	8:30 a.m. to 4:30 p.m. Monday to Friday inclusive
Gower Street	South	Adjacent to George Webster School grounds	Anytime

2. Schedule VIII (No Parking) of By-law No. 92-93, as amended, being a by-law of the former Borough of East York, is hereby further amended by inserting the following words and figures opposite each other in Columns 1, 2, 3 and 4 of the said Schedule:

(In Column 1 Road)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and Days)
Cedarcrest Boulevard	West	Glen Albert Drive and a point 34.5 metres south	Anytime
Cedarcrest Boulevard	West	A point 62 metres south of Glen Albert Drive and Gower Street	4:30 p.m. of one day to 8:30 a.m. of the next following day, inclusive
Gower Street	South	A point 26 metres east of Cedarcrest Boulevard and a point 11 metres further east	4:30 p.m. of one day to 8:30 a.m. of the next following day, inclusive
Gower Street	South	A point 37 metres east of Cedarcrest Boulevard and Dawes Road	Anytime

3. Schedule IX (No Stopping) of By-law No. 92-93, as amended, being a by-law of the former Borough of East York, is hereby further amended by inserting the following words and figures opposite each other in Columns 1, 2, 3 and 4 of the said Schedule:

(In Column 1 Road)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and Days)
Cedarcrest Boulevard	East	Gower Street and a point 71 metres north	8:30 a.m. to 4:30 p.m. Mon. to Fri.
Cedarcrest Boulevard	West	A point 34.5 metres south of Glen Albert Drive and a point 27.5 metres further south	Anytime
Gower Street	North	Cedarcrest Boulevard and a point 30.5 metres east	8:30 a.m. to 4:30 p.m. Mon. to Fri.

4. Schedule X (Parking for Restricted Periods) of By-law No. 92-93, as amended, being a by-law of the former Borough of East York, is hereby further amended by inserting the following words and figures opposite each other in Columns 1, 2, 3, 4 and 5 of the said Schedule:

(In Column 1 Road)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Times and Days)	(In Column 5 Max. Period Permitted)
Cedarcrest Boulevard	West	A point 62 metres south of Glen Albert Drive and Gower Street	8:30 a.m. to 4:30 p.m. Mon. to Fri.	10 mins.
Gower Street	South	A point 26 metres east of Cedarcrest Boulevard and a point 11 metres further east	8:30 a.m. to 4:30 p.m. Mon. to Fri.	10 mins.

5. Schedule XI (No Standing) of By-law No. 92-93, as amended, being a by-law of the former Borough of East York, is hereby further amended by striking out the following words and figures where they occur opposite each other in Columns 1, 2, 3 and 4 of the said Schedule:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times or Days)
Cedarcrest Boulevard	West	Gower Street and a point 73 metres north of Gower Street	8:30 a.m. to 4:30 p.m., Monday to Friday inclusive
Gower Street	South	Cedarcrest Boulevard and a point 61 metres east of Cedarcrest Boulevard	8:30 a.m. to 4:30 p.m., Monday to Friday inclusive
