BY-LAW No. 1136-2011

**To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking,
respecting Roncesvalles Avenue.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By deleting from Schedule XXIV (No Stopping) in § 400-77, the following in alphabetical order by street name:
