## **CITY OF TORONTO**

### **BY-LAW No. 1207-2011**

#### **To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Clinton Street, Euclid Avenue, Ordinance Street, Robinson Street, Roseheath Avenue and Strathmore Boulevard.**

The Toronto and East York Community Council HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

- A. By deleting from Schedule XXXVIII (Designated On-Street Parking for Disabled Person Parking Permit Holders) in § 400-91, the following in alphabetical order by street name:

(From Column 1)	(From Column 2)	(From Column 3)	(From Column 4)
Euclid Avenue	Both	A point 203 metres south of College Street and a point 5.5 metres further south	Anytime
Robinson Street	South	A point 36 metres west of Manning Avenue and a point 5.5 metres further west	Anytime

- B. By inserting in Schedule XXXVIII (Designated On-Street Parking for Disabled Person Parking Permit Holders) in § 400-91, the following in alphabetical order by street name:

(In Column 1)	(In Column 2)	(In Column 3)	(In Column 4)
Clinton Street	East	A point 22.1 metres north of Page Street and a point 5.5 metres further north	Anytime from the 1st day to the 15th day of each month, from Apr. 1 to Nov. 30, inclusive

(In Column 1)	(In Column 2)	(In Column 3)	(In Column 4)
Clinton Street	West	A point 25.6 metres north of Page Street and a point 5.5 metres further north	Anytime from Dec. 1 of one year to Mar. 31 of the next following year, inclusive, and from the 16th day to the last day of each month from Apr. 1 to Nov. 30, inclusive
Ordnance Street	North	A point 12.8 metres east of Strachan Avenue and a point 6.2 metres further east	Anytime
Roseheath Avenue	West	A point 41 metres south of Merrill Avenue West and a point 4 metres further south	Anytime
Strathmore Boulevard	North	A point 71 metres east of Woodmount Avenue and a point 5.5 metres further east	Anytime
