**CITY OF TORONTO**

**BY-LAW No. 1266-2011**

**To amend By-law No. 31001 of the former City of North York, respecting the regulation of traffic on North York roads, regarding Maxome Avenue and Pemberton Avenue.**

The North York Community Council HEREBY ENACTS as follows:

1. Schedule "XV" (Prohibited Turns) of By-law No. 31001, of the former City of North York, is amended by deleting from Columns 1, 2, 3 and 4 the following:

<b><u>COLUMN 1</u></b> <b><u>INTERSECTION OR</u></b> <b><u>PORTION OF</u></b> <b><u>HIGHWAY</u></b>	<b><u>COLUMN 2</u></b> <b><u>DIRECTION</u></b>	<b><u>COLUMN 3</u></b> <b><u>TURNS</u></b> <b><u>PROHIBITED</u></b>	<b><u>COLUMN 4</u></b> <b><u>TIMES OR</u></b> <b><u>DAYS</u></b>
Maxome Avenue at Pemberton Avenue	Southbound	Right Turn	7:00 a.m. to 10:00 a.m., Mon. to Fri.
Maxome Avenue at Pemberton Avenue	Eastbound	Left Turn	3:30 p.m. to 7:00 p.m., Mon. to Fri.

2. Schedule "XV" (Prohibited Turns) of By-law No. 31001, of the former City of North York is amended by adding to Columns 1, 2, 3 and 4 the following:

<b><u>COLUMN 1</u></b> <b><u>INTERSECTION OR</u></b> <b><u>PORTION OF</u></b> <b><u>HIGHWAY</u></b>	<b><u>COLUMN 2</u></b> <b><u>DIRECTION</u></b>	<b><u>COLUMN 3</u></b> <b><u>TURNS</u></b> <b><u>PROHIBITED</u></b>	<b><u>COLUMN 4</u></b> <b><u>TIMES OR</u></b> <b><u>DAYS</u></b>
Maxome Avenue and Pemberton Avenue	Southbound	Right	7:00 a.m. to 10:00 a.m., Mon. to Fri., school buses excepted
Maxome Avenue and Pemberton Avenue	Eastbound	Left	3:30 p.m. to 7:00 p.m., Mon. to Fri., school buses excepted
