BY-LAW No. 1282-2011

To amend further By-law No. 23503 of the former City of Scarborough, respecting the regulation of traffic on Hainford Street.

The Scarborough Community Council HEREBY ENACTS as follows:

1. Schedule VIII (No Parking) of By-law No. 23503 of the former City of Scarborough, as amended, is further amended by striking out the following words and figures in Columns 1, 2, 3 and 4 of the said Schedule:

Hainford Street	North	Manse Road	East Limit of Hainford Street	Anytime

The westerly northbound leg of Hainford Street and Hainford Street	The westerly northbound leg of Hainford Street
