BY-LAW No. 1046-2012

To expropriate portions of 998 and 1000 Woodbine Avenue and 666 and 668 Strathmore Boulevard for the Woodbine Station Easier Access and Second Exit Program.

WHEREAS in accordance with the provisions of the *Expropriations Act*, Applications for Approval to Expropriate Land were submitted to City Council, as approving authority, for approval to expropriate the lands and interests in land hereinafter described for the Woodbine Station Easier Access and Second Exit Program and for all works and uses ancillary thereto; and

WHEREAS Notices of the Applications for Approval to Expropriate Land were served on the registered owners of the said lands and interests in land; and

WHEREAS a notice in writing of a desire for a hearing with respect to the said proposed expropriations was not received from any owner of the said lands and the time for giving such notice has expired; and

WHEREAS City Council, as approving authority, has approved the said Applications for Approval to Expropriate Land;

The Council of the City of Toronto HEREBY ENACTS as follows:

- 1. The expropriation of the lands and interests in land described in Sections 2 and 3 hereof is hereby approved pursuant to sections 7, 8 and 9 of the *City of Toronto Act, 2006*, S.O. 2006, c. 11, Sched. A.
- 2. The fee simple interest, together with all other right, title and interest, in the lands described in Schedule "A" to this By-law is hereby expropriated and taken for the Woodbine Station Easier Access and Second Exit Program and for all works and uses ancillary thereto.
- **3.** A limited interest in the lands described in Schedule "B" to this By-law, being a temporary easement, for a limited time is hereby expropriated and taken for the purpose of (i) for the first address of Schedule "B", to access to part of the side yard of the Owner's Property for hoarding purposes during construction and installation of the underground connecting passage, second exit structure and other construction required in connection with the foregoing, and work ancillary thereto; and (ii) for the second and third address of Schedule "B", to installing caissons for an elevator structure and a temporary sidewalk in connection with the Woodbine Station Easier Access and Second Exit Program and for all works and uses ancillary thereto, including the right to pass over and occupy the lands with all personnel, materials and equipment, for said purposes for a period of two years from the date of expropriation.

- **4.** Authority is hereby granted for the signing, sealing and registration in the proper Land Registry Office of a plan showing the said lands and interests in land to be expropriated, including the payment of all expenses incidental thereto.
- **5.** City staff is hereby authorized to serve on the registered owners of the said lands and interests in land Notices of Expropriation (along with copies of Notices of Election as to a Date for Compensation) and Notices of Possession as contemplated by the *Expropriations Act*.
- 6. The Mayor and the proper officers of the City are hereby authorized and directed to do all things necessary to give effect to this by-law and the City Clerk and the Treasurer are hereby directed to execute all documents necessary in that behalf, and the Treasurer is hereby authorized and directed to affix the corporate seal of the City to all such documents.
