**CITY OF TORONTO**

**BY-LAW No. 1300-2012**

**To amend further Metropolitan By-law No. 32-92, respecting the regulation of traffic on former Metropolitan Roads, regarding Adelaide Street East, Gerrard Street East, King Street East, Sherbourne Street, Shuter Street and Wellesley Street East.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Schedule VIII (No Parking) of Metropolitan By-law No. 32-92, as amended, is hereby further amended by striking out the following words and figures where they occur opposite each other in Columns 1, 2, 3 and 4 of the said Schedule:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times or Days)
Adelaide Street East (M.T. 36)	North	Sherbourne Street and Power Street	Anytime
Adelaide Street (M.T. 36)	South	Berkeley Street and Power Street	Anytime

2. Schedule IX (No Stopping) of Metropolitan By-law No. 32-92, as amended, is hereby further amended by inserting the following words and figures opposite each other in Columns 1, 2, 3 and 4 of the said Schedule:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times or Days)
Adelaide Street East	Both	Berkeley Street and Eastern Avenue	Anytime
Adelaide Street East	North	Sherbourne Street and Berkeley Street	4:00 p.m. to 6:00 p.m. Mon. to Fri., except Public Holidays

3. Schedule XV (Prohibited Turns) of Metropolitan By-law No. 32-92, as amended, is hereby further amended by inserting the following words and figures opposite each other in Columns 1, 2, 3 and 4 of the said Schedule:

(In Column 1 Intersection or Portion of Highway)	(In Column 2 Direction)	(In Column 3 Turns Prohibited)	(In Column 4 Times or Days)
Sherbourne Street and Gerrard Street East	Eastbound and Westbound	Right	When traffic control signal shows red
Sherbourne Street and King Street East	Northbound and Southbound	Left	7:00 a.m. to 9:00 a.m. and 4:00 p.m. to 6:00 p.m. Mon. to Fri.
Sherbourne Street and Shuter Street	Eastbound and Westbound	Right	When traffic control signal shows red
Sherbourne Street and Shuter Street	Northbound and Southbound	Left	7:00 a.m. to 9:00 a.m. and 4:00 p.m. to 6:00 p.m. Mon. to Fri.
Sherbourne Street and Wellesley Street East	Eastbound and Westbound	Right	When traffic control signal shows red
