BY-LAW No. 39-2013

To amend By-law No. 31001 of the former City of North York, respecting the regulation of traffic on North York roads, regarding Mantello Drive, Sentinel Road and Hucknall Road.

The North York Community Council enacts:

1. Schedule "XVIII" (Through Highways) of By-law No. 31001, of the former City of North York, is amended by adding to Columns 1 and 2 the following:
