

Authority: Toronto and East York Community Council Item 22.62, as adopted by Toronto and East York Community Council on February 26, 2013 under the delegated authority of Sections 27-149B and 27-152 of City of Toronto Municipal Code Chapter 27, Council Procedures

CITY OF TORONTO

BY-LAW No. 374-2013

To amend City of Toronto Municipal Code Chapter 903, Parking for Persons with Disabilities, respecting Barrington Avenue, Bloomfield Avenue, Gloucester Grove, Lee Avenue, Mechanic Avenue, Rhodes Avenue, St. Clarens Avenue and Shaw Street.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 903, Parking for Persons with Disabilities, is amended as follows:
 - A. By deleting from Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order to street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time or Days)
Barrington Avenue	West	A point 128 metres south of Doncaster Avenue and a point 134.5 metres south of Doncaster Avenue	Anytime
Bloomfield Avenue	North	A point 88.5 metres west of Greenwood Avenue and a point 5.5 metres further west	Anytime
Bloomfield Avenue	South	A point 86.5 metres west of Greenwood Avenue and a point 5.5 metres further west	Anytime
Mechanic Avenue	East	A point 62.5 metres south of Wyndham Street and a point 5.5 metres further south	Anytime
St. Clarens Avenue	East	A point 82 metres north of College Street and a point 5.5 metres further north	Anytime, except each Thursday, from Apr. 1 to Nov. 30, 2005
St. Clarens Avenue	West	A point 82 metres north of College Street and a point 5.5 metres further north	Each Thursday, from Apr. 1 to Nov. 30, 2005

- B. By inserting in Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order to street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time or Days)
Gloucester Grove	North	A point 14 metres east of Everden Road and a point 5.5 metres further east	Anytime
Lee Avenue	West	A point 87.5 metres north of Len Stanley Way and a point 5.5 metres further north	Anytime
Rhodes Avenue	East	A point 282.5 metres north of Fairford Avenue and a point 5.5 metres further north	Anytime
Shaw Street	East	A point 30.6 metres north of Barton Avenue and a point 5.5 metres further north	Anytime
