BY-LAW No. 385-2013

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Rushton Road.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By deleting from Schedule XXV (Time Limit Parking) in § 400-78, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Times or Days)	(From Column 5 Maximum Period Permitted)
Rushton Road	East	Benson Avenue and a point 47 metres south of St. Clair Avenue West	10:00 a.m. to 6:00 p.m., from Dec. 1 of one year to Mar. 31 of the next following year, inclusive, and from the 1st day to the 15th day of each month, Apr. 1 to Nov. 30, inclusive	1 hour
Rushton Road	West	Benson Avenue and a point 47 metres south of St. Clair Avenue West	10:00 a.m. to 6:00 p.m., from the 16th day to the last day of each month, from Apr. 1 to Nov. 30, inclusive	1 hour

B. By inserting in Schedule XXV (Time Limit Parking) in § 400-78, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Times or Days)	(In Column 5 Maximum Period Permitted)
Rushton Road	East	St. Clair Avenue West and Benson Avenue	10:00 a.m. to 6:00 p.m. from Dec. 1 of one year to Mar. 31 of the next following year, inclusive	1 hour

C. By inserting in Schedule XXVIII (Alternate Side Parking) in § 400-81, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Parking Restrictions)	(In Column 5 Hours/Days)
Rushton Road	East	St. Clair Avenue West and Benson Avenue	60-minute parking; from Apr. 1 to Nov. 30	10:00 a.m. to 6:00 p.m. on the first day to the 15th day of each month, inclusive
Rushton Road	West	St. Clair Avenue West and Benson Avenue	60-minute parking; from Apr. 1 to Nov. 30	10:00 a.m. to 6:00 p.m. on the 16th day to the last day of each month, inclusive

D. By deleting from Schedule XXIX (No Standing) in § 400-82, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times or Days)
Rushton Road	Both	St. Clair Avenue West and a point 47 metres south	7:00 a.m. to 7:00 p.m., Mon. to Fri.
