BY-LAW No. 452-2013

To amend By-law No. 31001 of the former City of North York, respecting the regulation of traffic on North York roads, regarding McNicoll Avenue.

The Council of the City of Toronto enacts:

1. Schedule "X" (Parking for Restricted Times) of By-law No. 31001 of the former City of North York is amended by adding to Columns 1, 2, 3, 4 and 5 the following:

2. Schedule "VIII" (No Parking) of By-law No. 31001 of the former City of North York is amended by deleting from Columns 1, 2, 3 and 4 the following:

McNicoll Avenue	South	A point 80.5 metres east of the easterly limit of Don Mills Road	A point opposite the easterly limit of Rollingwood Drive

3. Schedule "IX" (No Stopping) of By-law No. 31001 of the former City of North York is amended by deleting from Columns 1, 2, 3 and 4 the following:
