

Authority: Etobicoke York Community Council Item 23.35, as adopted by Etobicoke York Community Council on April 9, 2013 under the delegated authority of Sections 27-149B and 27-152 of City of Toronto Municipal Code Chapter 27, Council Procedures

BY-LAW No. 496-2013

To amend By-law No. 31001 of the former City of North York, respecting the regulation of traffic on North York roads, regarding Abraham Welsh Road, Bob Yuill Drive, Charlie Jordan Road, Isaac Devins Boulevard, Mary Chapman Boulevard, McCartney Street, Parrotta Drive and various other streets within the Westown subdivision.

The Etobicoke York Community Council enacts:

1. Schedule "VIII" (No Parking) of By-law No. 31001, of the former City of North York, is amended by adding to Columns 1, 2, 3 and 4 the following:
