BY-LAW No. 536-2013

To amend City of Toronto Municipal Code Chapter 925, Permit Parking, respecting Parkmount Road.

Whereas Toronto and East York Community Council at its meeting of August 17, 2010 adopted Toronto and East York Community Council Item 36.86 entitled "Alternate Side Parking -Parkmount Road" and, in so doing, authorized amendments to permit parking regulations on Parkmount Road; and

Whereas Toronto and East York Community Council enacted By-law No. 945-2010 on August 17, 2010, in connection with the above-noted Item; and

Whereas Part B of By-law No. 945-2010 contained entries incorrectly referencing "Parkmount Avenue" instead of "Parkmount Road"; and

Whereas under Section 169-26 of Municipal Chapter 169, Officials, City, the City Solicitor, in consultation with the City Clerk, may submit bills directly to make technical amendments to The City of Toronto Municipal Code and other by-laws to correct technical errors;

The Toronto and East York Community Council enacts:
