

Authority: Toronto and East York Community Council Item 23.73, as adopted by Toronto and East York Community Council on April 9, 2013 under the delegated authority of Sections 27-149B and 27-152 of City of Toronto Municipal Code Chapter 27, Council Procedures

**CITY OF TORONTO**

**BY-LAW No. 549-2013**

**To amend City of Toronto Municipal Code Chapter 19, Business Improvement Areas, to include the new Leslieville Business Improvement Area and to establish a Board of Management for the Leslieville Business Improvement Area.**

Whereas Council, by the adoption of By-law No. 262-2013, designated an area along Queen Street East from Empire Avenue to Vancouver Avenue, as a Business Improvement Area under Municipal Code Chapter 19, Business Improvement Areas; and

Whereas Toronto and East York Community Council has established a board of management for the Leslieville Business Improvement Area, and appointed members to the Leslieville Business Improvement Area Board of Management for a term expiring on November 30, 2014, or as soon thereafter as successors are appointed; and

Whereas Schedule A of City of Toronto Municipal Code Chapter 19, Business Improvement Areas, must be amended to include the new Leslieville Business Improvement Area Board of Management;

The Toronto and East York Community Council enacts:

1. The City of Toronto Municipal Code Chapter 19, Business Improvement Areas, is amended as follows:
  - (1) The table in Schedule A, Boards of Management, is amended by adding the new Leslieville Board of Management as set out in Schedule A attached; and
  - (2) Schedule A, Maps, is amended by adding the attached maps of the Leslieville Business Improvement Area.
2. A Board of Management for the Leslieville Business Improvement Area is hereby established.

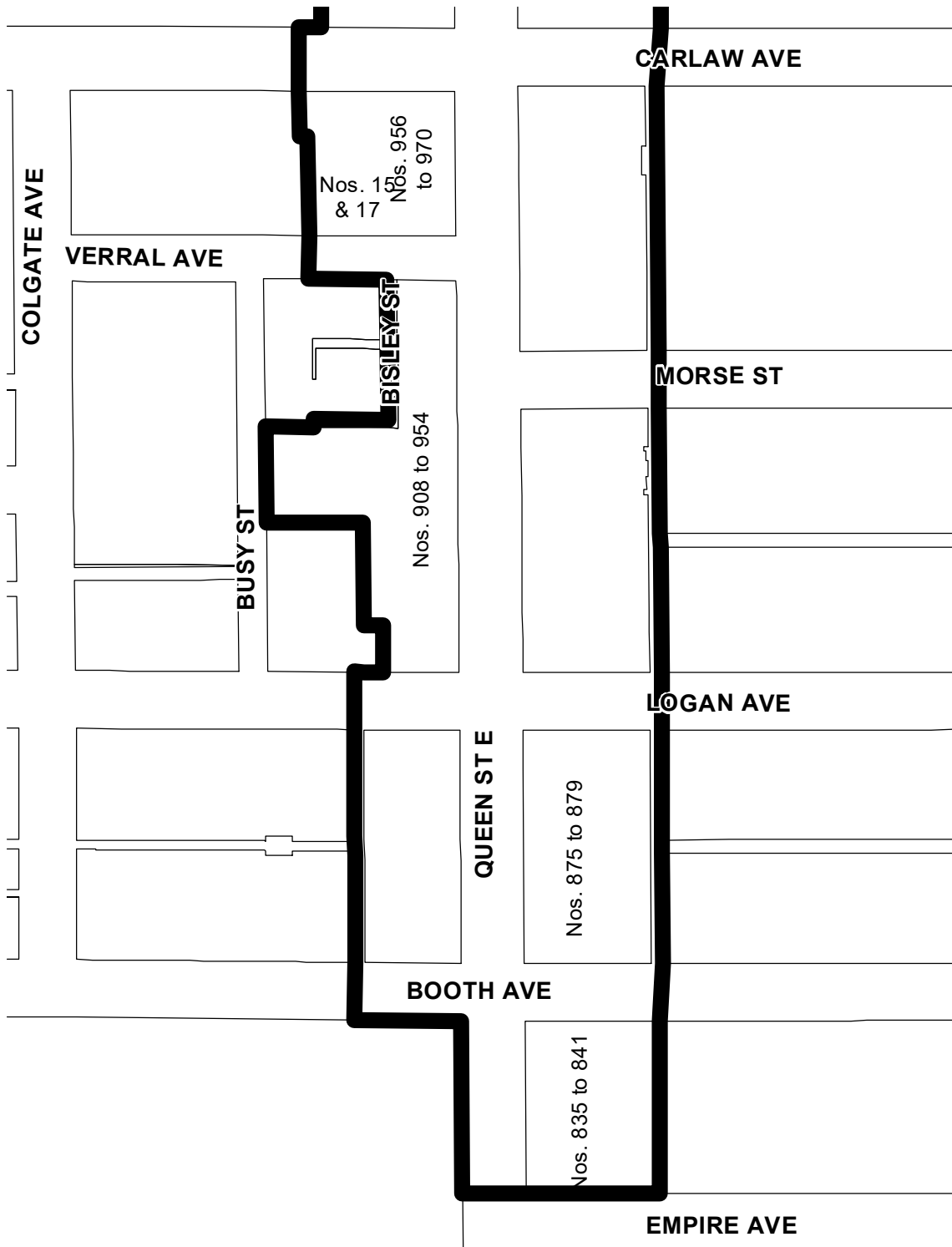

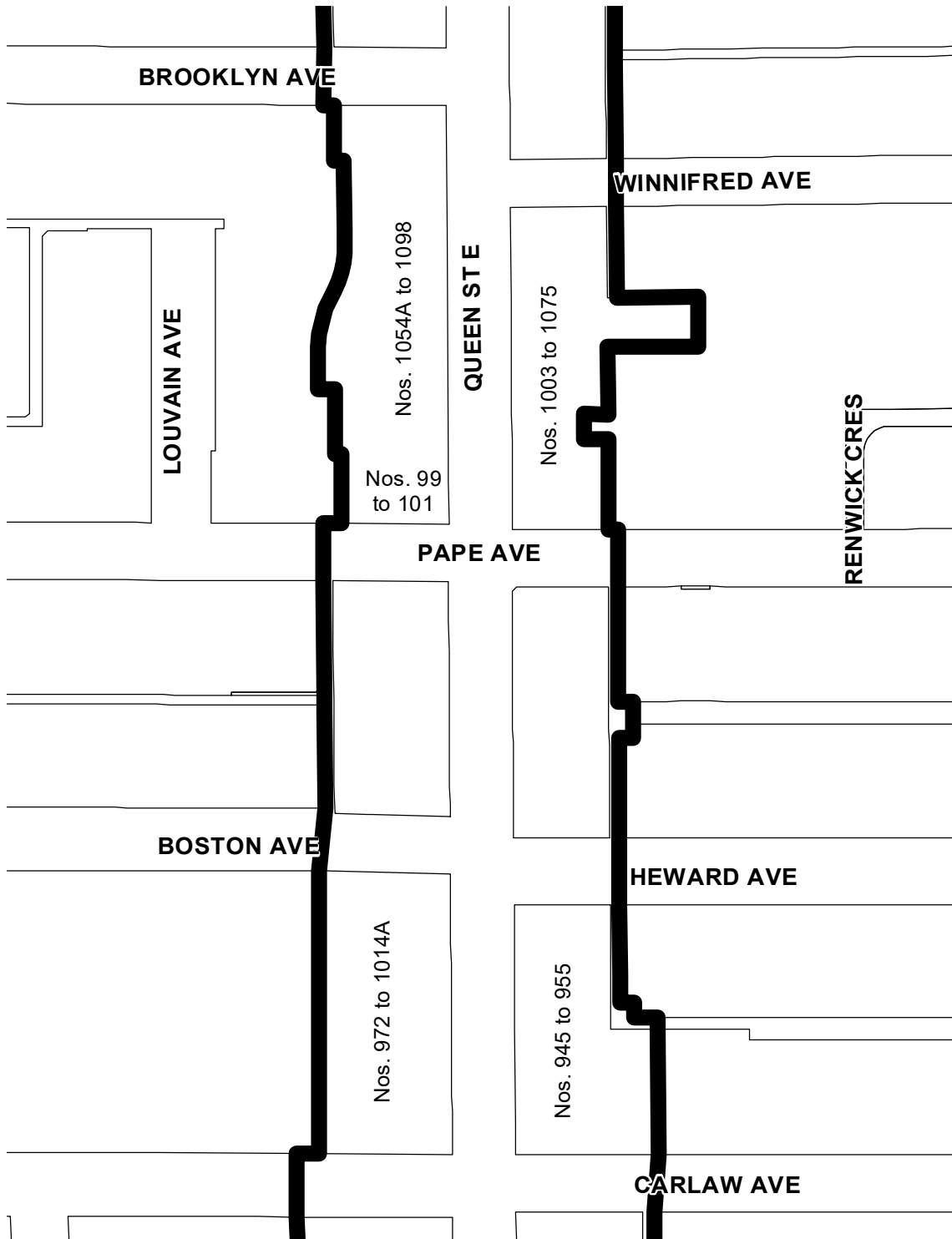


Leslieville Business Improvement Area

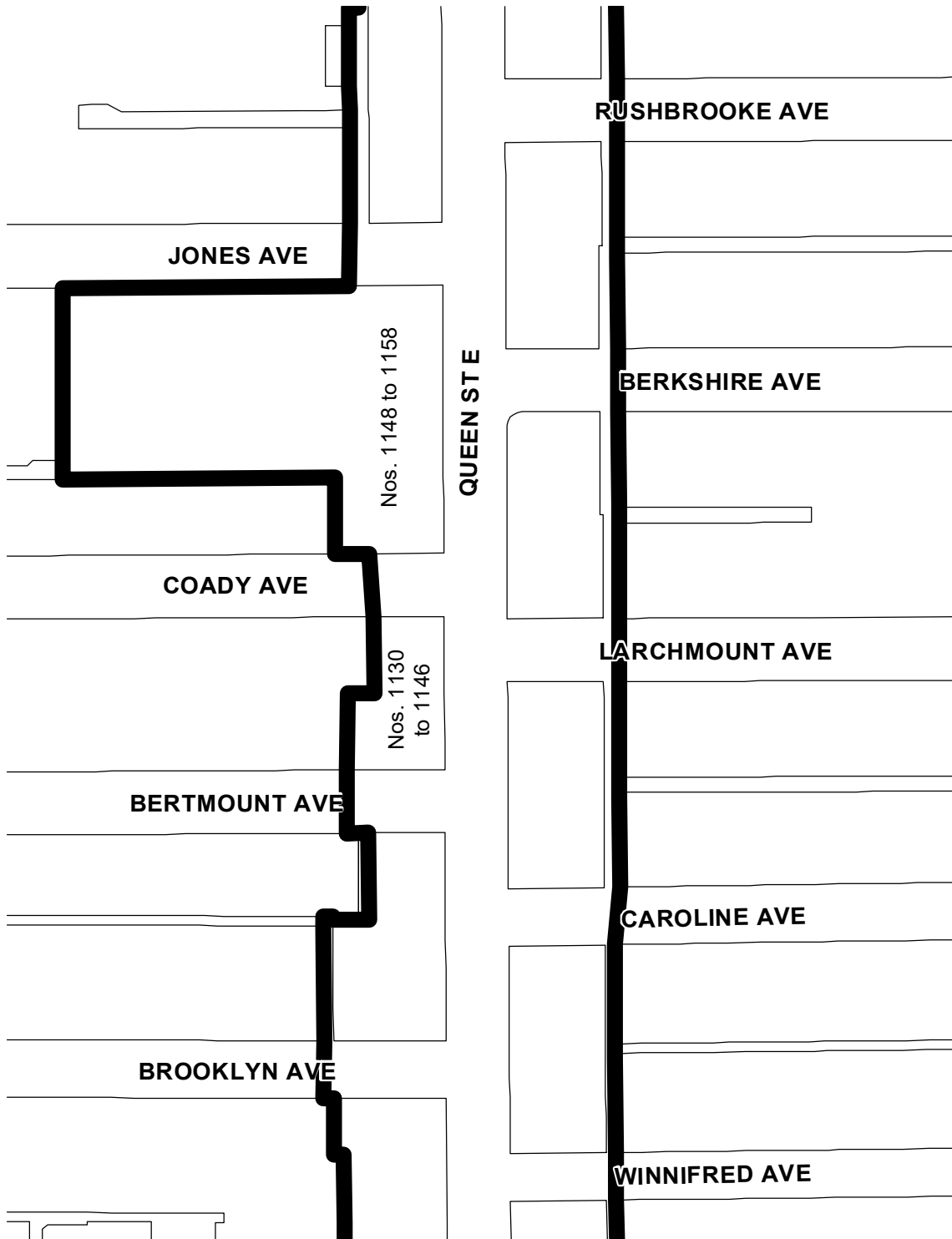

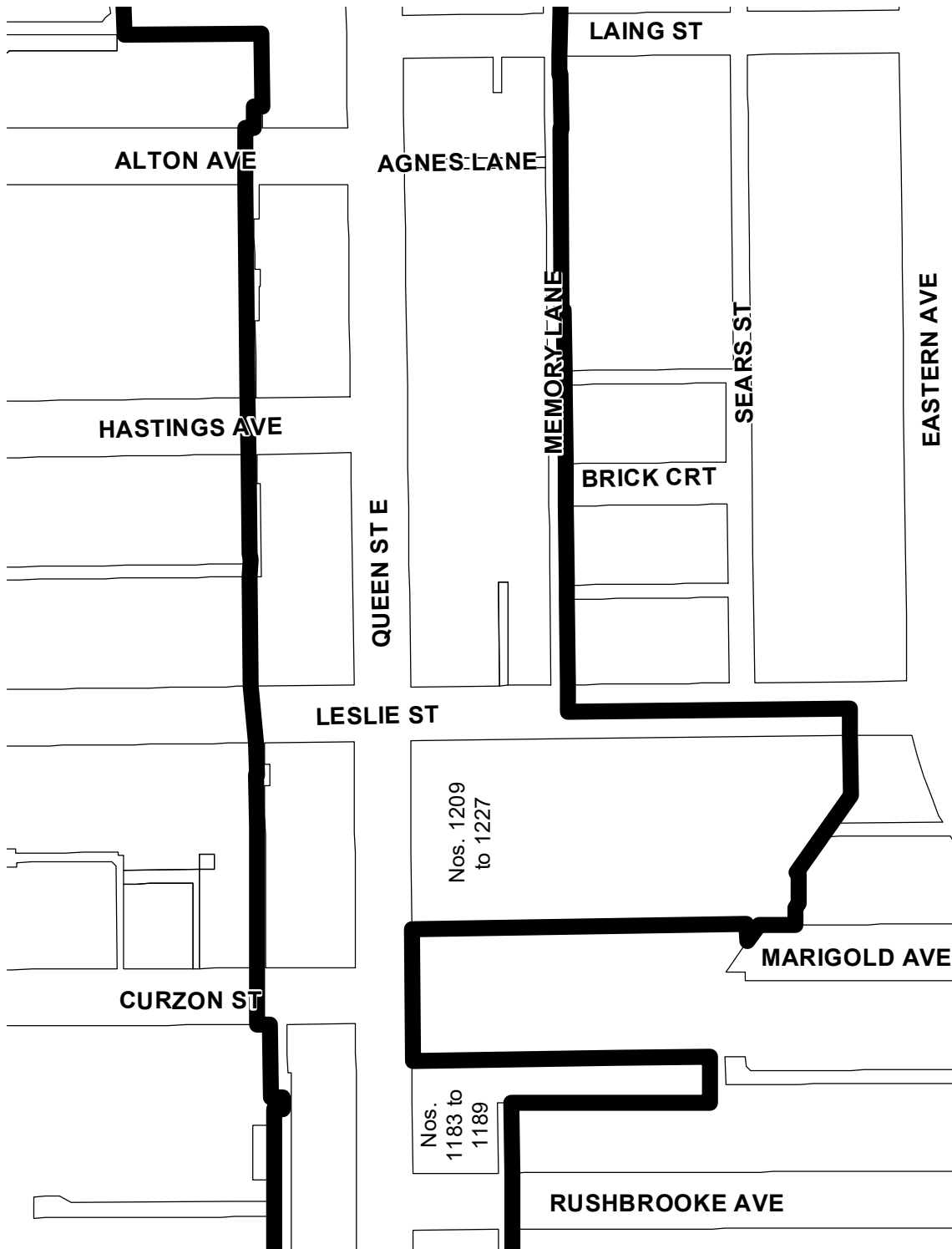

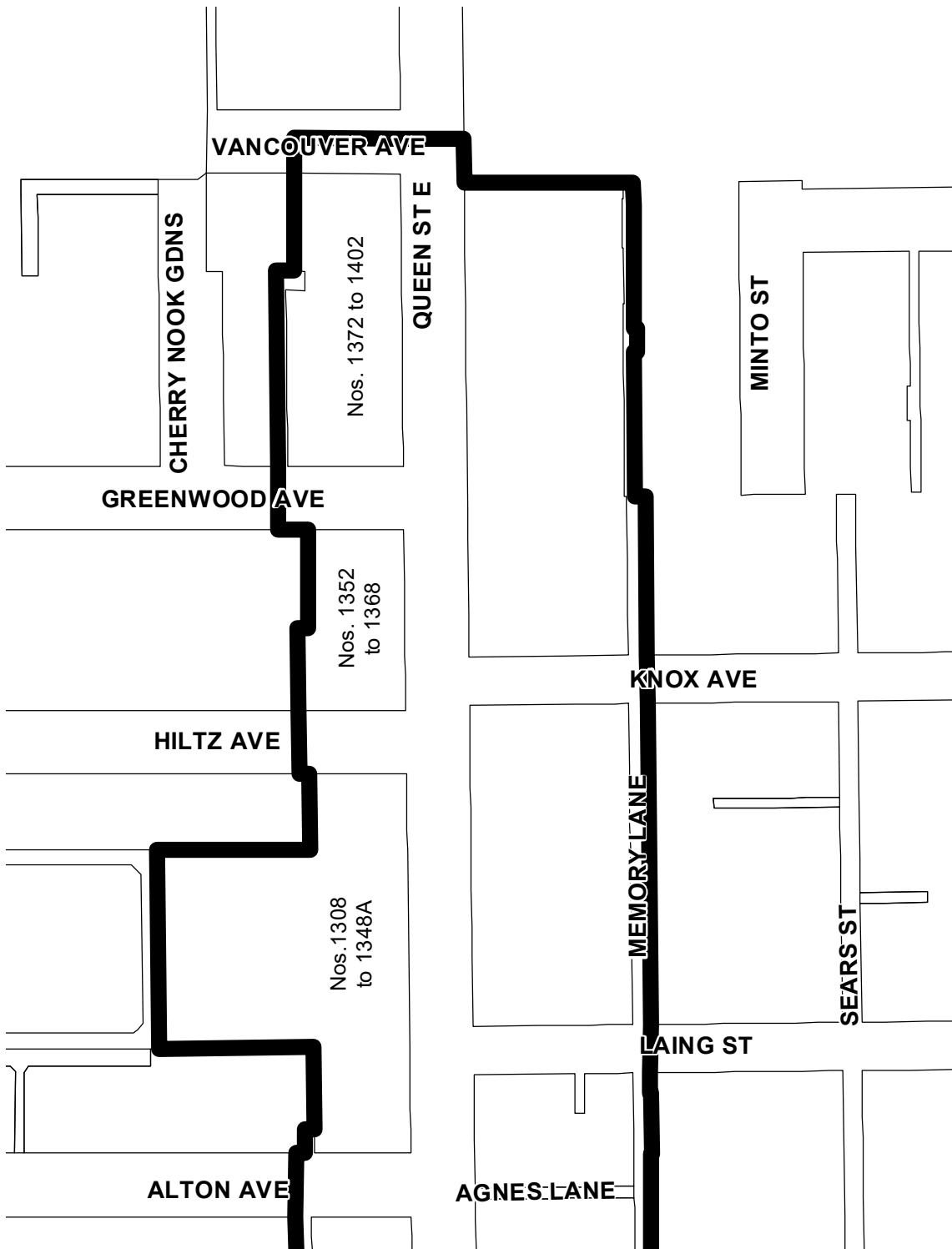


Leslieville Business Improvement Area
