BY-LAW No. 556-2013

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Fulton Avenue.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:
 - A. By deleting from Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

Fulton Avenue	South	Carlaw Avenue and the east City limit	10:00 a.m. to 6:00 p.m. from Dec. 1 of one year to Mar. 31 of the next following year, inclusive
