CITY OF TORONTO

BY-LAW No. 563-2013

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Bastion Street, Blue Jays Way, Brunel Court, Church Street, Dundonald Street, Emily Street, Frederick Street, Guest Avenue, Irwin Avenue and Walnut Avenue.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:
