BY-LAW No. 608-2013

To amend further Metropolitan By-law No. 32-92, respecting the regulation of traffic on former Metropolitan Roads, regarding Adelaide Street West.

The Council of the City of Toronto enacts:

1. Schedule VIII (No Parking) of Metropolitan Toronto By-law No. 32-92, as amended, is further amended by striking out the following words and figures:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times or Days)
Adelaide Street West	South	A point 15 metres west of Morrison Street and a point 37 metres east of Brant Street	Anytime
Adelaide Street West	South	A point 97 metres east of Brant Street and a point 15 metres west of Charlotte Street	Anytime

where they occur opposite each other in Columns 1, 2, 3 and 4 of the said Schedule and inserting in lieu thereof the following:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times or Days)
Adelaide Street West	South	A point 15 metres west of Morrison Street and a point 15 metres west of Charlotte Street	Anytime

2. Schedule IX (No Stopping) of Metropolitan Toronto By-law No. 32-92, as amended, is further amended by striking out the following words and figures:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times or Days)
Adelaide Street West	South	A point 37 metres east of Brant Street and a point 97 metres east of Brant Street	Anytime
