BY-LAW No. 790-2013

To amend further Metropolitan By-law No. 32-92, respecting the regulation of traffic on former Metropolitan Roads, regarding Richmond Street East.

The Council of the City of Toronto enacts:

1. Schedule VIII (No Parking) of Metropolitan By-law No. 32-92, as amended, is further amended by striking out the following words and figures:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times or Days)
Richmond Street East	North	A point 39.7 metres east of Sherbourne Street and a point 62 metres west of Ontario Street	9:00 a.m. to 6:00 p.m. Mon. to Fri. except Public Holidays

where they occur opposite each other in Columns 1, 2, 3 and 4 of the said Schedule and inserting in lieu thereof the following:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times or Days)
Richmond Street East	North	Sherbourne Street and a point 62 metres west of Ontario Street	9:00 a.m. to 6:00 p.m. Mon. to Fri., except public holidays

2. Schedule IX (No Stopping) of Metropolitan By-law No. 32-92, as amended, is further amended by striking out the following words and figures:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times or Days)
Richmond Street East	North	Sherbourne Street and a point 4 metres west	7:00 a.m. to 9:00 a.m. Mon. to Fri. except Public Holidays
Richmond Street East	North	Sherbourne Street and a point 39.7 metres east	Anytime
Richmond Street East	North	A point 39.7 metres east of Sherbourne Street and Power Street	7:00 a.m. to 9:00 a.m. Mon. to Fri. except Public Holidays

where they occur opposite each other in Columns 1, 2, 3 and 4 of the said Schedule and inserting in lieu thereof the following:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times or Days)
Richmond Street East	North	A point 4 metres west of Sherbourne Street and Power Street	7:00 a.m. to 9:00 a.m. Mon. to Fri., except public holidays
