BY-LAW No. 869-2013

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Ranleigh Avenue.

The North York Community Council enacts:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By deleting from Schedule XI (School Bus Loading Zones) in § 400-64, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Location)
Ranleigh Avenue	South side, between a point 176.3 metres east of Yonge Street and a point 63.7 metres further east thereof

B. By inserting in Schedule XI (School Bus Loading Zones) in § 400-64, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Location)
Ranleigh Avenue	South side, between a point 235 metres east of Yonge Street and a point 30 metres further east

C. By deleting from Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Ranleigh Avenue	South	Yonge Street and Mount Pleasant Road	Anytime

D. By inserting in Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Ranleigh Avenue	South	Yonge Street and a point 140 metres east	Anytime
Ranleigh Avenue	South	A point 140 metres east of Yonge Street and a point 125 metres further east	4:00 p.m. of one day to 8:00 a.m. of the next following day, Mon. to Fri.; Anytime on Sat. and Sun.
Ranleigh Avenue	South	A point 265 metres east of Yonge Street and Mount Pleasant Road	Anytime

E. By inserting in Schedule XXIV (No Stopping) in § 400-77, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times)
Ranleigh Avenue	North	A point 140 metres east of Yonge Street and a point 125 metres further east	8:00 a.m. to 4:00 p.m. Mon. to Fri.
Ranleigh Avenue	South	A point 235 metres east of Yonge Street and a point 30 metres further east	Anytime (buses excepted)

F. By deleting from Schedule XXV (Time Limit Parking) in § 400-78, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Times or Days)	(From Column 5 Maximum Period Permitted)
Ranleigh Avenue	North	A point 138 metres east of Yonge Street and a point 87.5 metres further east	8:30 a.m. to 9:15 a.m., 11:15 a.m. to 1:15 p.m. and 2:45 p.m. to 4:00 p.m., Mon. to Fri.	10 mins.

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Times or Days)	(From Column 5 Maximum Period Permitted)
Ranleigh Avenue	North	A point 225.5 metres east of Yonge Street and a point 28 metres further east	8:30 a.m. to 9:15 a.m., 11:15 a.m. to 1:15 p.m. and 2:45 p.m. to 4:00 p.m., Mon. to Fri.	10 mins.

G. By inserting in Schedule XXV (Time Limit Parking) in § 400-78, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Times or Days)	(In Column 5 Maximum Period Permitted)
Ranleigh Avenue	South	A point 140 metres east of Yonge Street and a point 95 metres further east	8:00 a.m. to 4:00 p.m. Mon. to Fri.	10 mins.
