CITY OF TORONTO

BY-LAW No. 991-2013

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Dufferin Street, Jameson Avenue, Springhurst Avenue and Tyndall Avenue.

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

- A. By inserting in Schedule I (One-Way Highways) in § 400-54, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Between)	(In Column 3 Time or Days)	(In Column 4 Direction)
Springhurst Avenue	Dufferin Street and Tyndall Avenue (east branch)	Anytime from and including Fri. Aug. 16, 2013 to and including Mon. Sept. 2, 2013	Westbound

- B. By inserting in Schedule VIII (Prohibited Turns) in § 400-61, the following in alphabetical order by street name:

(In Column 1 Intersection or Portion of Road)	(In Column 2 Direction)	(In Column 3 Turns Prohibited)	(In Column 4 Times and/or Days)
Springhurst Avenue and Jameson Avenue	Westbound	Left	7:00 a.m. to 9:00 a.m. and 4:00 p.m. to 6:00 p.m., Mon. to Fri., from and including Fri. Aug. 16, 2013 to and including Mon. Sept. 2, 2013

- C. By inserting in Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times or Days)
Dufferin Street	East	A point 15 metres north of Springhurst Avenue and Queen Street West	Anytime from and including Fri. Aug. 16, 2013 to and including Mon. Sept. 2, 2013

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times or Days)
Dufferin Street	West	King Street West and Queen Street West	Anytime from and including Fri. Aug. 16, 2013 to and including Mon. Sept. 2, 2013

D. By inserting in Schedule XXIX (No Standing) in § 400-82, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times or Days)
Dufferin Street	West	Springhurst Avenue and Thorburn Avenue	Anytime from and including Fri. Aug. 16, 2013 to and including Mon. Sept. 2, 2013
Springhurst Avenue	North	Jameson Avenue and Dufferin Street	Anytime from and including Fri. Aug. 16, 2013 to and including Mon. Sept. 2, 2013
Springhurst Avenue	South	Dunn Avenue and Spencer Avenue	Anytime from and including Fri. Aug. 16, 2013 to and including Mon. Sept. 2, 2013
Tyndall Avenue	East	Springhurst Avenue and Thorburn Avenue	Anytime from and including Fri. Aug. 16, 2013 to and including Mon. Sept. 2, 2013

E. By inserting in Schedule XXXII (Taxi-Cab Stands) in § 400-85, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Location)	(In Column 4 Number of Taxicabs)	(In Column 5 Hours)
Dufferin Street	West	Thorburn Avenue and a point 29 metres south of King Street West	25	Anytime from and including Fri. Aug. 16, 2013 to and including Mon. Sept. 2, 2013
