**CITY OF TORONTO**

**BY-LAW No. 1039-2013**

**To amend further Metropolitan By-law No. 32-92, respecting the regulation of traffic on  
former Metropolitan Roads, regarding Adelaide Street West.**

The Council of the City of Toronto enacts:

1. Schedule VI (Prohibited Pedestrian Crossings) of Metropolitan By-law No. 32-92, as amended, is further amended by striking out the following words and figures:

From (Column 1 Highway)	(From Column 2 Location)
Adelaide Street West (M.T. 36)	Between the west curb line of Sheppard Street and a point 30.5 metres east of the east curb line of Sheppard Street

where they occur opposite each other in Columns 1 and 2 of the said Schedule and inserting in lieu thereof the following:

(In Column 1 Highway)	(In Column 2 Location)
Adelaide Street West	Between the east curb line of Sheppard Street and a point 30.5 metres west of the west curb line of Sheppard Street

2. Schedule VIII (No Parking) of Metropolitan By-law No. 32-92, as amended, is further amended by striking out the following words and figures:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times or Days)
Adelaide Street West	North	Sheppard Street and Yonge Street	Anytime

where they occur opposite each other in Columns 1, 2, 3 and 4 of the said Schedule and inserting in lieu thereof the following:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times or Days)
Adelaide Street West	North	Simcoe Street and a point 84 metres west of Sheppard Street	Anytime
Adelaide Street West	North	Sheppard Street and Bay Street	Anytime

3. Schedule IX (No Stopping) of Metropolitan By-law No. 32-92, as amended, is further amended by striking out the following words and figures:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times or Days)
Adelaide Street West (M.T. 36)	North	Duncan Street and a point 30.5 metres west of Sheppard Street	7:30 a.m. to 9:30 a.m. and 3:30 p.m. to 6:30 p.m. Monday to Friday, except Public Holidays

where they occur opposite each other in Columns 1, 2, 3 and 4 of the said Schedule and inserting in lieu thereof the following:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times or Days)
Adelaide Street West	North	A point 30.5 metres west of Sheppard Street and a point 53.5 metres further west	Anytime
Adelaide Street West	North	Duncan Street and a point 84 metres west of Sheppard Street	7:30 a.m. to 9:30 a.m. and 3:30 p.m. to 6:30 p.m. Mon. to Fri., except public holidays

4. Schedule XI (No Standing) of Metropolitan By-law No. 32-92, as amended, is further amended by striking out the following words and figures:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times or Days)
Adelaide Street West (M.T. 36)	North	University Avenue and a point 30.5 metres west of Sheppard Street	11:30 a.m. to 1:30 p.m. Monday to Friday, except Public Holidays

where they occur opposite each other in Columns 1, 2, 3 and 4 of the said Schedule and inserting in lieu thereof the following:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times or Days)
Adelaide Street West	North	University Avenue and a point 84 metres west of Sheppard Street	11:30 a.m. to 1:30 p.m. Mon. to Fri., except public holidays

5. This By-law shall be effective commencing July 17, 2013.
