CITY OF TORONTO

BY-LAW No. 1089-2013

To amend former City of Toronto Municipal Code Chapter 400, Traffic and Parking, City of Toronto Municipal Code Chapter 886, Footpaths, Pedestrian Ways, Bicycle Paths, Bicycle Lanes and Cycle Tracks, City of Toronto Municipal Code Chapter 925, Permit Parking, and City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting bicycle lanes on Brock Avenue.

Whereas City Council, at its meeting of August 5 and 6, 2009, adopted as amended, Public Works and Infrastructure Committee Item 25.20 entitled "2009 Bikeway Network Program - Installation of Bicycle Lanes" and in so doing approved the installation of bicycle lanes on Brock Avenue, from a point 25 metres north of Seaforth Avenue to Florence Street; and

Whereas City of Toronto Council, on July 8, 2010, enacted By-law Nos. 833-2010, 834-2010 and 835-2010 in connection with the above-noted Item, to amend various traffic and parking By-laws/Municipal Codes with respect to the installation of bicycle lanes on Brock Avenue; and

Whereas portions of the above-noted By-laws were incorrect in that they did not take into account overnight permit parking on the even (west) side of Brock Avenue, between Seaforth Avenue and Florence Street; and

Whereas under Section 169-26 of City of Toronto Municipal Code Chapter 169, Officials, City, the City Solicitor, in consultation with the City Clerk, may submit bills directly to make technical amendments to The City of Toronto Municipal Code and other by-laws to correct technical errors;

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:
 - A. By deleting from Schedule XXIV (No Stopping) in § 400-77, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times)
Brock Avenue	West	A point 25 metres north of Seaforth Avenue and Florence Street	Anytime

- B. By inserting in Schedule XXIV (No Stopping) in § 400-77, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times)
Brock Avenue	West	A point 25 metres north of Seaforth Avenue and a point 35.8 metres north of Seaforth Avenue	Anytime
Brock Avenue	West	A point 57.8 metres north of Seaforth Avenue and Florence Street	Anytime

2. Municipal Code Chapter 886, Footpaths, Pedestrian Ways, Bicycle Paths, Bicycle Lanes and Cycle Tracks is amended as follows:

- A. By deleting from Schedule D (Designated Lanes for Bicycles) the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Between)	(From Column 3 Lanes)	(From Column 4 Times or Days)
Brock Avenue	A point 25 metres north of Seaforth Avenue and Florence Street	Easterly Northbound and Westerly Southbound	Anytime

- B. By inserting in Schedule D (Designated Lanes for Bicycles) the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Between)	(In Column 3 Lanes)	(In Column 4 Times or Days)
Brock Avenue	A point 25 metres north of Seaforth Avenue and Florence Street	Easterly Northbound	Anytime
Brock Avenue	A point 25 metres north of Seaforth Avenue and a point 35.8 metres north of Seaforth Avenue	Westerly Southbound	Anytime
Brock Avenue	A point 35.8 metres north of Seaforth Avenue and a point 57.8 metres north of Seaforth Avenue	Westerly Southbound lane adjacent to the curb lane used for parking	Anytime

(In Column 1 Highway)	(In Column 2 Between)	(In Column 3 Lanes)	(In Column 4 Times or Days)
Brock Avenue	A point 57.8 metres north of Seaforth Avenue and Florence Street	Westerly Southbound	Anytime

3. Municipal Code Chapter 925, Permit Parking, is amended as follows:

A. By deleting from Schedule A (Permit Parking) the following in alphabetical order by street name:

(From Column 1 Street)	(From Column 2 Side)	(From Column 3 Location)	(From Column 4 Period)	(From Column 5 Time)
Brock Avenue	Even	From Seaforth Avenue to a point 25 metres north	All times	12:01 a.m. to 7:00 a.m.

B. By inserting in Schedule A (Permit Parking) the following in alphabetical order by street name:

(In Column 1 Street)	(In Column 2 Side)	(In Column 3 Location)	(In Column 4 Period)	(In Column 5 Time)
Brock Avenue	Even	From a point 35.8 metres north of Seaforth Avenue to a point 57.8 metres north of Seaforth Avenue	All times	12:01 a.m. to 7:00 a.m.

4. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Brock Avenue	West	A point 25 metres north of Seaforth Avenue and Florence Street	Anytime

B. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Brock Avenue	West	A point 25 metres north of Seaforth Avenue and a point 35.8 metres north of Seaforth Avenue	Anytime
Brock Avenue	West	A point 57.8 metres north of Seaforth Avenue and Florence Street	Anytime
