

Authority: Etobicoke York Community Council Item 26.31, as adopted by Etobicoke York Community Council on September 10, 2013 under the delegated authority of Sections 27-149B and 27-152 of City of Toronto Municipal Code Chapter 27, Council Procedures

**CITY OF TORONTO**

**BY-LAW No. 1142-2013**

**To amend City of Toronto Municipal Code Chapter 903, Parking for Persons with Disabilities, respecting Biggar Avenue, Peterborough Avenue, St. Johns Road and Vine Avenue.**

The Etobicoke York Community Council enacts:

1. Municipal Code Chapter 903, Parking for Persons with Disabilities, is amended as follows:
  - A. By deleting from Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time or Days)
Vine Avenue	South	A point 102 metres west of Keele Street and a point 5.5 metres further west	Anytime
Peterborough Avenue	North	A point 50 metres west of Dufferin Street and a point 5.5 metres further west	Anytime
Peterborough Avenue	North	A point 43 metres west of Dufferin Street and a point 5.5 metres further west	Anytime
Peterborough Avenue	South	A point 18.5 metres west of McFarland Avenue and a point 5.5 metres further west	Anytime

- B. By inserting in Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time or Days)
St. Johns Road	South	A point 23 metres west of Beresford Avenue and a point 5.5 metres further west	Anytime

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time or Days)
Biggar Avenue	North	A point 42 metres east of Oakwood Avenue and a point 5.5 metres further east	Anytime from the 1 <sup>st</sup> day to the 15 <sup>th</sup> day of each month from Apr. 1 to Nov. 30, inclusive
Biggar Avenue	South	A point 41 metres east of Oakwood Avenue and a point 5.5 metres further east	Anytime from Dec. 1 of one year to Mar. 31 of the next following year, inclusive, and from the 16 <sup>th</sup> day to the last day of each month from Apr. 1 to Nov. 30, inclusive
