BY-LAW No. 1378-2013

To amend City of Toronto Municipal Code Chapter 19, Business Improvement Areas, to include the new Wilson-Keele Business Improvement Area and to establish a Board of Management for the Wilson-Keele Business Improvement Area.

Whereas Council, by the adoption of By-law No. 1299-2013, designated an area along Wilson Avenue from approximately Keele Street to approximately William R. Allen Street North, as a business improvement area under Municipal Code Chapter 19, Business Improvement Areas; and

Whereas North York Community Council has established a board of management for the Wilson-Keele Business Improvement Area, and appointed members to the Wilson-Keele Business Improvement Area Board of Management for a term expiring on November 30, 2014, or as soon thereafter as successors are appointed; and

Whereas Schedule A of the City of Toronto Municipal Code Chapter 19, Business Improvement Areas, must be amended to include the new Wilson-Keele Business Improvement Area Board of Management;

The North York Community Council enacts:

- **1.** The City of Toronto Municipal Code Chapter 19, Business Improvement Areas, is amended as follows:
 - (1) The table in Schedule A, Boards of Management, is amended by adding the new Wilson-Keele Board of Management as set out in Schedule A attached; and
 - (2) Schedule A, Maps, is amended by adding the attached maps of the Wilson-Keele Business Improvement Area.
- **2.** A Board of Management for the Wilson-Keele Business Improvement Area is hereby established.
