BY-LAW No. 1413-2013

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Cole Street, Oak Street, Regent Street and Sackville Street.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By inserting in Schedule I (One-Way Highways) in § 400-54, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Between)	(In Column 3 Time or Days)	(In Column 4 Direction)
Cole Street	Parliament Street and Sackville Street	Anytime	Eastbound
Regent Street	Cole Street and Oak Street	Anytime	Northbound
Sackville Street	Dundas Street East and Oak Street	Anytime	Southbound

B. By inserting in Schedule IV (Stop Intersections) in § 400-57, the following in alphabetical order by street name:

(In Column 1 Intersections)	(In Column 2 Stop Streets)
Cole Street and Regent Street	Cole Street
Cole Street and Sackville Street	Cole Street (eastbound)
Oak Street and Sackville Street	Oak Street
Regent Street and Cole Street	Regent Street
Regent Street and Oak Street	Regent Street (northbound)
Sackville Street and Oak Street	Sackville Street

C. By deleting from Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(In Column 4 Prohibited Times or Days)
Sackville Street	East	Queen Street East and Shuter Street Entire length	Anytime, from Dec. 1 of one year to Mar. 31 of the next following year, inclusive

D. By inserting in Schedule XXIII (No Parking) in § 400-76, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times or Days)
Cole Street	North	A point 15 metres east of Parliament Street and a point 21.5 metres further east	10.00 a.m. to 3:30 p.m. and 6:00 p.m. of one day to 7:00 a.m. of the next following day; anytime Sat. and Sun.
Cole Street	South	Parliament Street and Sackville Street	Anytime
Oak Street	North	Parliament Street and Sackville Street	Anytime
Regent Street	Both	Dundas Street East and Cole Street	Anytime
Regent Street	West	Cole Street and Oak Street	Anytime
Sackville Street	East	Dundas Street East and Oak Street	Anytime
Sackville Street	East	Queen Street East and Shuter Street	Anytime from Dec. 1 of one year to Mar. 31 of the next following year, inclusive
Sackville Street	West	Cole Street and a point 15 metres south	Anytime
Sackville Street	West	Dundas Street East and a point 34 metres south of Cole Street	Anytime

E. By inserting in Schedule XXV (Time Limit Parking) in § 400-78, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Times or Days)	(In Column 5 Maximum Period Permitted)
Cole Street	North	A point 15 metres east of Parliament Street and a point 21.5 metres further east	7:00 a.m. to 10:00 a.m. and 3:30 p.m. to 6:00 p.m. Mon. to Fri.	15 mins.

F. By inserting in Schedule XXIX (No Standing) in § 400-82, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times or Days)
Sackville Street	West	A point 15 metres south of Cole Street and a point 19 metres further south	Anytime
