## **CITY OF TORONTO**

### **BY-LAW No. 1471-2013**

#### **To amend former City of Toronto Municipal Code Chapter 400, Traffic and Parking, respecting Elizabeth Street/Dr. Emily Stowe Way and Grenville Street.**

As City of Toronto Council, at its meeting held on May 7, 8, 9 and 10, 2013, adopted without amendment Toronto and East York Community Council Item 23.2 entitled "Renaming of a Portion of Elizabeth Street Extending Northerly from College Street to Grenville Street" (Ward 27) and on July 19, 2013 enacted By-law No. 1041-2013 to rename Elizabeth Street, between College Street and Grenville Street, as "Dr. Emily Stowe Way"; and

As under Section 169-26 of Municipal Code Chapter 169, Officials, City, the City Solicitor, in consultation with the City Clerk, may submit bills directly to make technical amendments to The City of Toronto Municipal Code and other by-laws to correct technical errors;

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By deleting from Schedule I (One-Way Highways) in § 400-54 the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Between)	(From Column 3 Time or Days)	(From Column 4 Direction)
Elizabeth Street (west roadway of traffic island)	Grenville Street and a point 15.2 metres south thereof	Anytime	From north to south

B. By inserting in Schedule I (One-Way Highways) in § 400-54 the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Between)	(In Column 3 Time or Days)	(In Column 4 Direction)
Dr. Emily Stowe Way (west roadway of traffic island)	Grenville Street and a point 15.2 metres south	Anytime	Southbound

- C. By deleting from Schedule IV (Stop Intersections) in § 400-57, the following in alphabetical order by street name:

(From Column 1 Intersections)	(From Column 2 Stop Streets)
Elizabeth Street and Grenville Street	Elizabeth Street
Grenville Street and Elizabeth Street	Grenville Street

- D. By inserting in Schedule IV (Stop Intersections) in § 400-57 the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Between)
Dr. Emily Stowe Way and Grenville Street	Dr. Emily Stowe Way
Grenville Street and Dr. Emily Stowe Way	Grenville Street

- E. By deleting from Schedule XVIII (Weight Limits on Highways) in § 400-71 the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Between)	(From Column 3 Times or Days)
Elizabeth Street	College Street and Grenville Street	Anytime

- F. By inserting in Schedule XVIII (Weight Limits on Highways) in § 400-71 the following in alphabetical order by street name:

Dr. Emily Stowe Way	College Street and Grenville Street	Anytime

G. By deleting from Schedule XXV (Time Limit Parking) in § 400-78 the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Times or Days)	(From Column 5 Maximum Period Permitted)
Elizabeth Street	West	Grenville Street and College Street	8:00 a.m. to 6:00 p.m.	60 mins.

H. By deleting from Schedule XXIX (No Standing) in § 400-82 the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times)
Elizabeth Street	Both	College Street and Grenville Street	Anytime
Grenville Street	South	A point 19.0 metres east of Elizabeth Street and Bay Street	Anytime
Grenville Street	South	Surrey Place and Elizabeth Street	Anytime

I. By inserting in Schedule XXIX (No Standing) in § 400-82 the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times)
Dr. Emily Stowe Way	Both	College Street and Grenville Street	Anytime
Grenville Street	South	A point 19.0 metres east of Dr. Emily Stowe Way and Bay Street	Anytime
Grenville Street	South	Surrey Place and Dr. Emily Stowe Way	Anytime
