**CITY OF TORONTO**

**BY-LAW No. 54-2014**

**To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Henry Lane Terrace.**

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Henry Lane Terrace	North	A point 12.5 metres west of George Street South (north intersection) and a point 34 metres further west	9:30 a.m. to 11:30 a.m., 1:30 p.m. to 3:15 p.m., 5:30 p.m. of one day to 7:30 a.m. of the next following day, Mon. to Fri.; 12:01 a.m. to 7:30 a.m., Sat. to Mon.

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Henry Lane Terrace (north branch)	North	A point 12.5 metres west of George Street South (north intersection) and a point 34 metres further west	9:30 a.m. to 11:30 a.m., 1:30 p.m. to 3:15 p.m., and 6:15 p.m. of one day to 7:30 a.m. of the next following day, Mon. to Fri.; 12:01 a.m. to 7:30 a.m. Sat. to Mon.

C. By deleting from Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time and/or Days)	(From Column 5 Maximum Period Permitted)
Henry Lane Terrace (north branch)	North	A point 12.5 metres west of George Street South and a point 34 metres further west	7:30 a.m. to 9:30 a.m., 11:30 a.m. to 1:30 p.m. and 3:15 p.m. to 5:30 p.m., Mon. to Fri.	10 mins.

D. By inserting in Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time and/or Days)	(In Column 5 Maximum Period Permitted)
Henry Lane Terrace (north branch)	North	A point 12.5 metres west of George Street South (north intersection) and a point 34 metres further west	7:30 a.m. to 9:30 a.m., 11:30 a.m. to 1:30 p.m. and 3:15 p.m. to 6:15 p.m., Mon. to Fri.	10 mins.
