**CITY OF TORONTO**

**BY-LAW No. 55-2014**

**To amend City of Toronto Municipal Code Chapter 19, Business Improvement Areas, to include the new College-Dufferin Business Improvement Area and to establish a Board of Management for the College-Dufferin Business Improvement Area.**

Whereas Council, by the adoption of By-law No. 1300-2013, designated an area along College Street between approximately Lansdowne Avenue and approximately Rusholme Road, as a Business Improvement Area under Municipal Code Chapter 19, Business Improvement Areas; and

Whereas Toronto and East York Community Council has established a board of management for the College-Dufferin Business Improvement Area, and appointed members to the College-Dufferin Business Improvement Area Board of Management for a term expiring on November 30, 2014, or as soon thereafter as successors are appointed; and

Whereas Schedule A of City of Toronto Municipal Code Chapter 19, Business Improvement Areas, must be amended to include the new College-Dufferin Business Improvement Area Board of Management;

The Toronto and East York Community Council enacts:

1. The City of Toronto Municipal Code Chapter 19, Business Improvement Areas, is amended as follows:
  - (1) The table in Schedule A, Boards of Management, is amended by adding the new College-Dufferin Board of Management as set out in Schedule A attached; and
  - (2) Schedule A, Maps, is amended by adding the attached maps of the College-Dufferin Business Improvement Area.
2. A Board of Management for the College-Dufferin Business Improvement Area is hereby established.

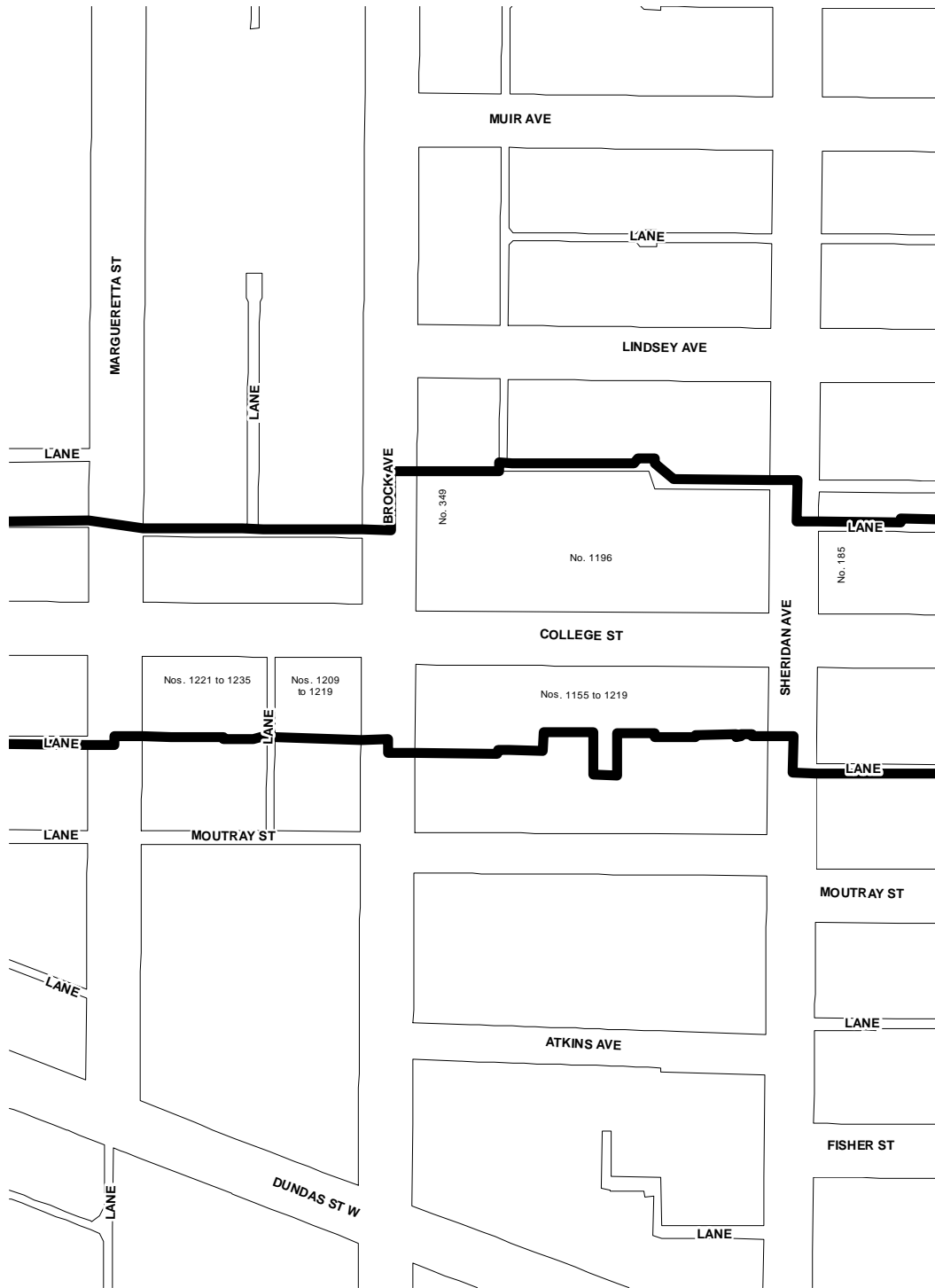

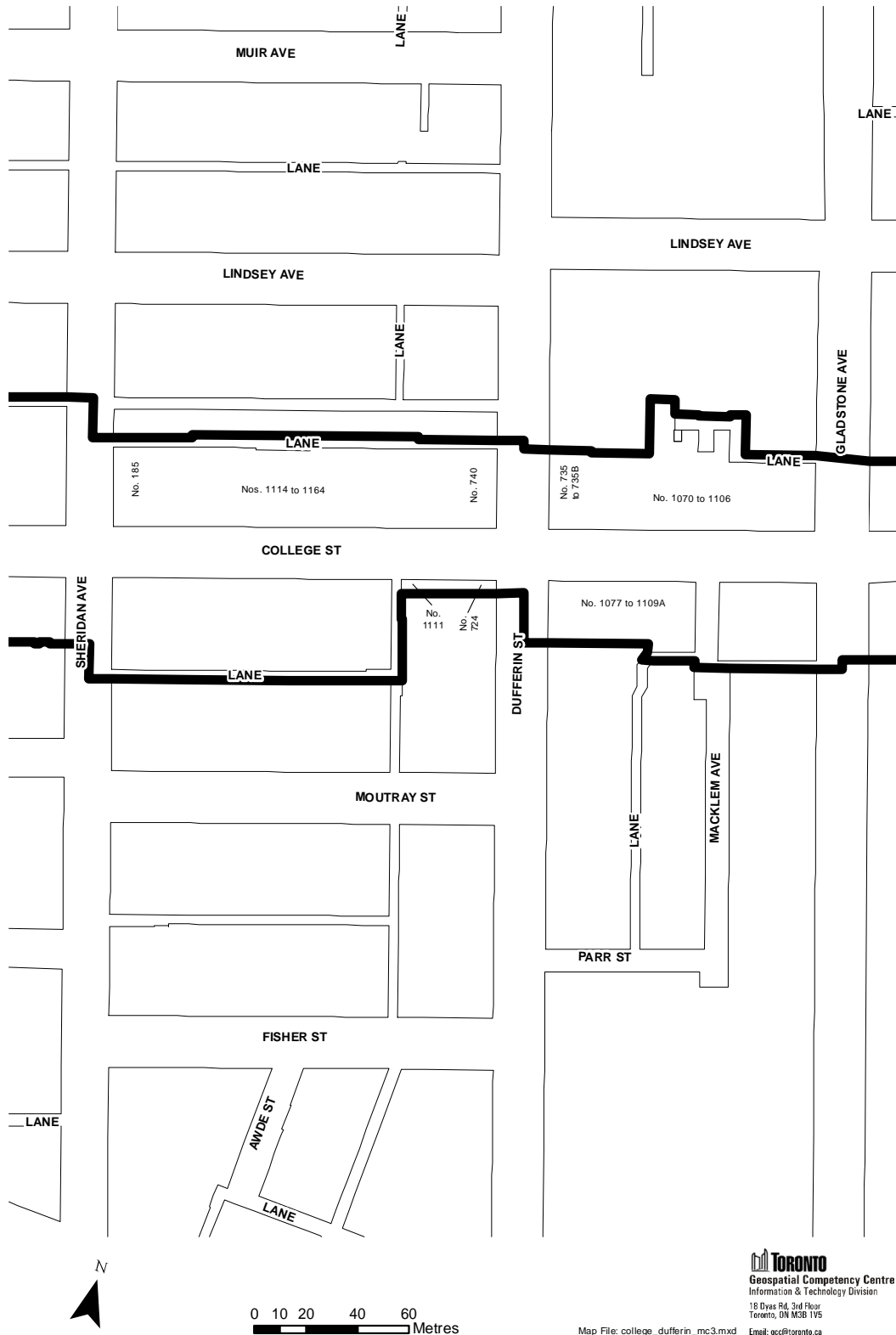
