BY-LAW No. 113-2014

To amend Schedule "C" of By-law No. 32-2011, being a by-law to designate 5 Eireann Quay (Canada Malting Complex) as being of cultural heritage value or interest.

Whereas the City passed By-law No. 32-2011, being a by-law to designate 5 Eireann Quay (Canada Malting Complex) as being of cultural heritage value or interest; and

Whereas Schedule "C" of By-law No. 32-2011 indicates that 5 Eireann Quay is located in Ward 5; and

Whereas 5 Eireann Quay is located in Ward 20; and

Whereas under Section 169-26 of City of Toronto Municipal Code Chapter 169, Officials, City, the City Solicitor, in consultation with the City Clerk, may submit bills directly to Council to make technical amendments to the Municipal Code and other by-laws to correct technical errors;

The Council of the City of Toronto enacts:

1. Schedule "C" of By-law No. 32-2011 is deleted and replaced with Schedule "C" attached to this by-law.
2. The City Solicitor is authorized to cause a copy of this by-law to be registered against title to the property at 5 Eireann Quay, more particularly described in Schedule "A" and shown on Schedule "C" attached to this by-law in the proper land registry office.

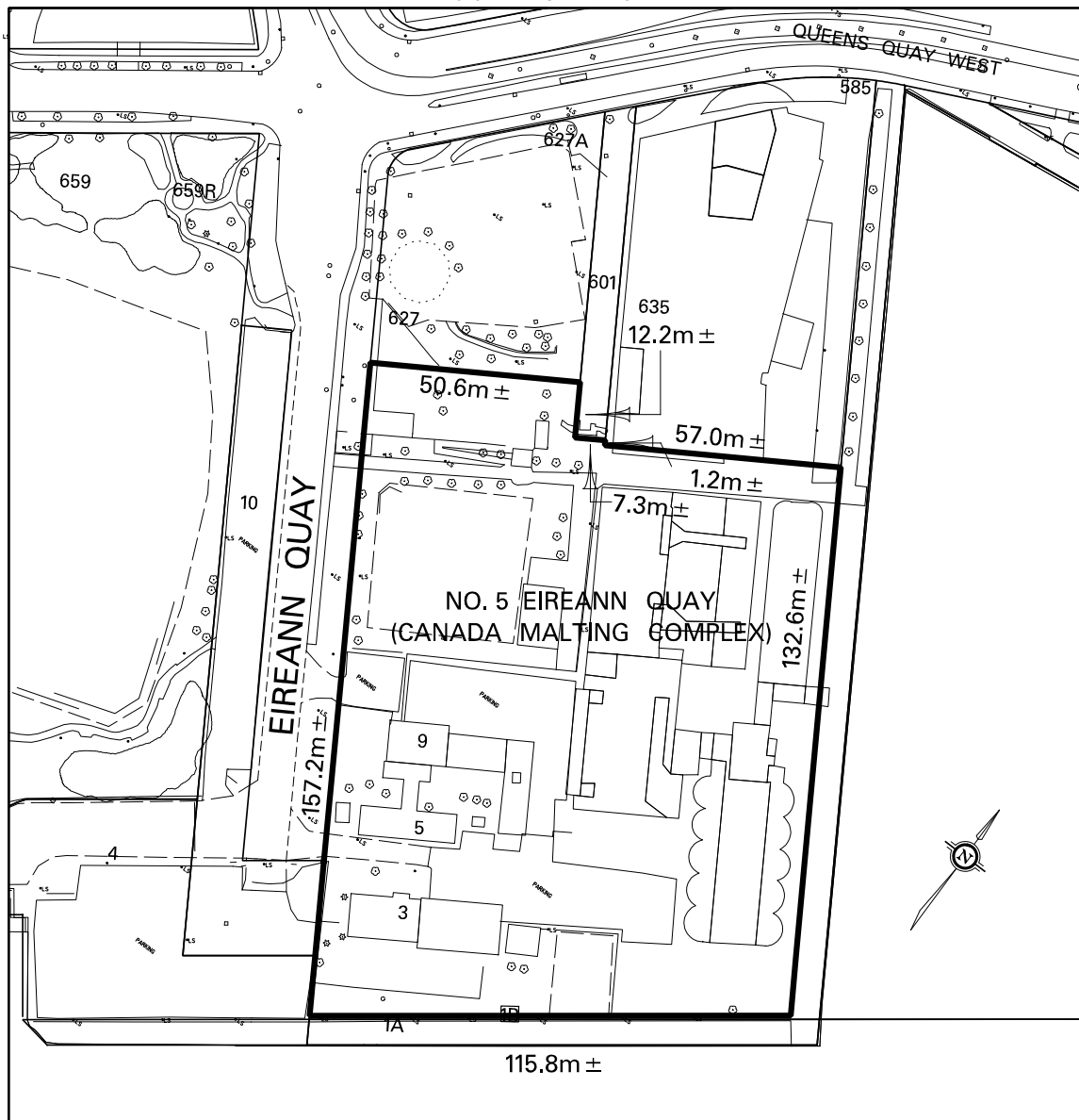
