## BY-LAW No. 234-2014

## To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Adelaide Street West and Richmond Street West.

As City of Toronto Council, at its meeting of June 27, 28 and 29, 2006, adopted without amendment Toronto and East York Community Council Report 5, Clause 73, entitled "Introduction of Trial 2:00 a.m. to 6:00 a.m., Friday to Monday Standing Prohibition - Richmond Street West and Adelaide Street West, between University Avenue and Spadina Avenue (Ward 20 - Trinity-Spadina)" and, in so doing, approved standing prohibitions from 2:00 a.m. to 6:00 a.m., Friday through Monday, on the subject sections of Adelaide Street West and Richmond Street West; and

As City of Toronto Council enacted By-law No. 595-2006 on June 29, 2006, in connection with the above-noted Clause; and

As the above-mentioned By-law No. 595-2006 contained typographical errors in two entries and prohibited standing from 4:00 a.m. to 6:00 a.m. Friday through Monday, on both sides of Adelaide Street West, between John Street and a point 30.5 metres west of Duncan Street, and on the north side of Richmond Street West, between Peter Street and a point 53 metres east, instead of prohibiting standing from 2:00 a.m. to 6:00 a.m. Friday through Monday, as was adopted by City Council; and

As the aforementioned typographical errors were carried forward into Municipal Code Chapter 950, Traffic and Parking, when traffic and parking By-laws/Codes were consolidated under By-law No. 1409-2011, enacted by City Council on December 1, 2011; and

As under Section 169-26 of Chapter 169, Officials, City, of The City of Toronto Municipal Code, the City Solicitor, in consultation with the City Clerk, may submit bills directly to make technical amendments to The City of Toronto Municipal Code and other by-laws to correct technical errors;

The Council of the City of Toronto enacts:

- 1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
- A. By deleting from Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:
