## **CITY OF TORONTO**

### **BY-LAW No. 343-2014**

**To amend City of Toronto Municipal Code Chapter 903, Parking for Persons with Disabilities, respecting Craven Road, Fuller Avenue, Fulton Avenue, Gladstone Avenue, Hammersmith Avenue, Hannaford Street, Kent Road, Manning Avenue, Pearson Avenue, Rusholme Road, Salem Avenue, Shaw Street and Sudbury Street.**

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 903, Parking for Persons with Disabilities, is amended as follows:
  - A. By deleting from Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time or Days)
Craven Road	East	A point 89.5 metres north of Dundas Street East and a point 5.5 metres further north	Anytime
Gladstone Avenue	East	A point 117 metres south of Dupont Street and a point 5.5 metres further south	Anytime
Hannaford Street	East	A point 67 metres north of Kingston Road and a point 5.5 metres further north	Anytime
Salem Avenue	West	A point 27.5 metres north of Bloor Street West and a point 5.5 metres further north	Anytime

- B. By inserting in Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time or Days)
Fuller Avenue	West	A point 117 metres south of Marion Street and a point 5.5 metres further south	Anytime
Fulton Avenue	North	A point 99 metres east of Jackman Avenue and a point 5.5 metres further east	Anytime

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time or Days)
Hammersmith Avenue	East	A point 114 metres north of Hubbard Boulevard and a point 5.5 metres further north	Anytime
Hammersmith Avenue	West	A point 110 metres north of Hubbard Boulevard and a point 5.5 metres further north	Anytime
Kent Road	East	A point 33 metres south of Dundas Street East and a point 5.5 metres further south	Anytime
Kent Road	West	A point 25 metres south of Dundas Street East and a point 5.5 metres further south	Anytime
Manning Avenue	West	A point 81.4 metres south of Dundas Street West and a point 5.5 metres further south	Anytime
Pearson Avenue	South	A point 181 metres west of Sorauren Avenue and a point 6 metres further west	Anytime
Rusholme Road	East	A point 65 metres north of College Street and a point 5.5 metres further north	Anytime
Shaw Street	West	A point 52.9 metres north of College Street and a point 5.5 metres further north	Anytime
Sudbury Street	North	A point 76.5 metres west of King Street West and a point 5.5 metres further west	Anytime
