## BY-LAW No. 475-2014

To amend City of Toronto Municipal Code Chapter 903, Parking for Persons with Disabilities, respecting Chisholm Avenue, Durant Avenue, Glebemount Avenue, Hampton Avenue, Marigold Avenue, Northcote Avenue, Palmerston Boulevard, Roblocke Avenue, Triller Avenue, Ulster Street, Winona Drive, Wolverleigh Boulevard and Wychwood Avenue.

The Toronto and East York Community Council enacts:

- **1.** Municipal Code Chapter 903, Parking for Persons with Disabilities, is amended as follows:
- A. By deleting from Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:
