BY-LAW No. 481-2014

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Bruyeres Mews, Grand Magazine Street and Iannuzzi Street.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:
