

Authority: Toronto and East York Community Council Item 33.72, as adopted by Toronto and East York Community Council on June 17, 2014 under the delegated authority of Sections 27-149B and 27-152 of City of Toronto Municipal Code Chapter 27, Council Procedures

CITY OF TORONTO

BY-LAW No. 628-2014

To amend City of Toronto Municipal Code Chapter 903, Parking for Persons with Disabilities, respecting Albany Avenue, Booth Avenue, Fairford Avenue, Hazelton Avenue, Indian Road, Lawlor Avenue, Melita Crescent, Merrill Avenue West, Rhodes Avenue and Roseheath Avenue.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 903, Parking for Persons with Disabilities, is amended as follows:
 - A. By deleting from Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time or Days)
Albany Avenue	East	A point 44 metres south of Dupont Street and a point 5.5 metres further south	Anytime
Albany Avenue	East	A point 49.5 metres south of Dupont Street and a point 5.5 metres further south	Anytime
Booth Avenue	West	A point 101.8 metres north of Eastern Avenue and a point 5.5 metres further north	Anytime
Fairford Avenue	South	A point 15.3 metres east of Craven Road and a point 5.5 metres further east	Anytime
Indian Road	West	A point 52 metres north of Garden Avenue and a point 5.5 metres further north	Anytime
Rhodes Avenue	East	A point 149 metres south of Danforth Avenue and a point 5.5 metres further south	Anytime
Rhodes Avenue	West	A point 149.5 metres south of Danforth Avenue and a point 5.5 metres further south	Anytime

B. By inserting in Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time or Days)
Hazelton Avenue	East	A point 44 metres south of Davenport Road and a point 5.5 metres further south	Anytime
Lawlor Avenue	West	A point 99 metres north of Kingston Road and a point 5.5 metres further north	Anytime
Melita Crescent	North	A point 24.5 metres east of the west of Melita Crescent and a point 5.5 metres further east	Anytime
Merrill Avenue West	North	A point 48 metres west of East Lynn Avenue and a point 5.5 metres further west	Anytime
Roseheath Avenue	West	A point 44 metres south of Stacy Street and a point 5.5 metres further south	Anytime
