CITY OF TORONTO

BY-LAW No. 704-2014

To amend City of Toronto Municipal Code Chapter 441, Fees and Charges, to reflect the extension and continuation into 2015 of certain 2014 water and wastewater consumption rates and service fees and 2014 solid waste management service rates enacted by By-law No. 1698-2013 and By-law No. 136-2014.

Whereas section 259 of the *City of Toronto Act, 2006* provides that the City may pass by-laws imposing fees or charges on persons for services or activities provided or done by or on behalf of it; and

Whereas City Council has the authority to pass this by-law pursuant to subsections 8 (1) and (2) and section 259 of the *City of Toronto Act, 2006*; and

Whereas City Council at its meeting on December 18, 2013 enacted By-law No. 1698-2013 which, among other things, set the new water and wastewater consumption rates and service fees to be charged to metered and flat rate consumers effective in 2014, public notice having been given; and

Whereas City Council at its meeting on February 20, 2014 enacted By-law No. 136-2014 which, among other things, set the new solid waste management service rates to be charged effective on January 1, 2014, public notice having been given; and

Whereas City Council has now approved the extension and continuation of the 2014 water and wastewater consumption rates and service fees into 2015 until such time that City Council adopts Toronto Water's 2015 Operating and Capital Budgets and any corresponding changes, which may be necessary, to the water and wastewater consumption rates and service fees, public notice having been given; and

Whereas City Council has now approved the extension and continuation of certain 2014 solid waste management service rates until such time that City Council adopts the 2015 Operating and Capital Budgets for Solid Waste Management Services and any corresponding changes, which may be necessary, to the solid waste management service rates, public notice having been given; and

Whereas Chapter 441 of The City of Toronto Municipal Code is the codified consolidated user fee by-law for the City of Toronto ("Municipal Code Chapter 441"); and

Whereas City Council has approved amendments to Chapter 441 of The City of Toronto Municipal Code to provide that all fees and charges approved by City Council and set out in the Appendices to Chapter 441 continue in full force and effect until such time as they are amended or repealed; The Council of the City of Toronto enacts:

- 1. The 2014 Water and Wastewater Consumption Rates and Service Fees set out in Attachment 1 to this By-law, be extended and continued until amended.
- 2. The 2014 Solid Waste Management Service Rates set out in Attachment 2 to this By-law, be extended and continued until amended.
- **3.** Chapter 441, Fees and Charges, be amended by adding the following section:

§ 441-12. Continuation of fees and charges.

All fees and charges set out in the Appendices to this Chapter continue in full force and effect until such time as they are amended or repealed, unless otherwise set out this or another Chapter.

- 4. (1) This By-law shall come into force on the day it is enacted.
 - (2) Notwithstanding (1), Sections 1 and 2 of this By-law shall come into force on January 1, 2015.
