## **CITY OF TORONTO**

### **BY-LAW No. 766-2014**

#### **To amend City of Toronto Municipal Code Chapter 903, Parking for Persons with Disabilities, respecting Ashburnham Road, Branstone Road, Holmesdale Crescent, Larkin Avenue, McRoberts Avenue, Royal Street and Windermere Avenue.**

The Etobicoke York Community Council enacts:

1. Municipal Code Chapter 903, Parking for Persons with Disabilities, is amended as follows:

A. By deleting from Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time or Days)
Ashburnham Road	South	A point 67 metres west of Via Italia and a point 5.5 metres further west	Anytime
McRoberts Avenue	East	A point 1 metre south of a point opposite the south curb of Corby Avenue and a point 5.5 metres further north	Anytime
Windermere Avenue	East	A point 57 metres south of Deforest Road and a point 5.5 metres further south	Anytime

B. By inserting in Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time or Days)
Ashburnham Road	South	A point 53.3 metres west of Via Italia and a point 5.5 metres further west	Anytime
Branstone Road	East	A point 70.5 metres north of the south leg of Branstone Road and a point 5.5 metres further north	Anytime

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time or Days)
Holmesdale Crescent	East	A point 10.3 metres north of Holmesdale Road and a point 6 metres further north	Anytime
Larkin Avenue	North	A point 34 metres west of Armada Avenue and a point 5.5 metres further west	Anytime from the 1 <sup>st</sup> day to the 15 <sup>th</sup> day of each month from Apr. 1 to Nov. 30, inclusive
Larkin Avenue	South	A point 35 metres west of Armada Avenue and a point 5.5 metres further west	Anytime from Dec. 1 of one year to Mar. 31 of the next following year, inclusive, and from the 16 <sup>th</sup> day to the last day of each month from Apr. 1 to Nov. 30, inclusive
Royal Street	East	A point 104.2 metres north of Henrietta Street and a point 5.5 metres further north	Anytime
