

Authority: North York Community Council Item 34.11, as adopted by North York Community Council on August 12, 2014 under the delegated authority of Sections 27-149B and 27-152 of City of Toronto Municipal Code Chapter 27, Council Procedures

CITY OF TORONTO

BY-LAW No. 778-2014

To authorize the naming of a public lane located south of Eglinton Avenue West and extending easterly from Oakwood Avenue as "Reggae Lane".

Whereas pursuant to § 27-152E(5) of City of Toronto Municipal Code Chapter 27, Council Procedures, North York Community Council has the authority to pass a by-law naming the public lane;

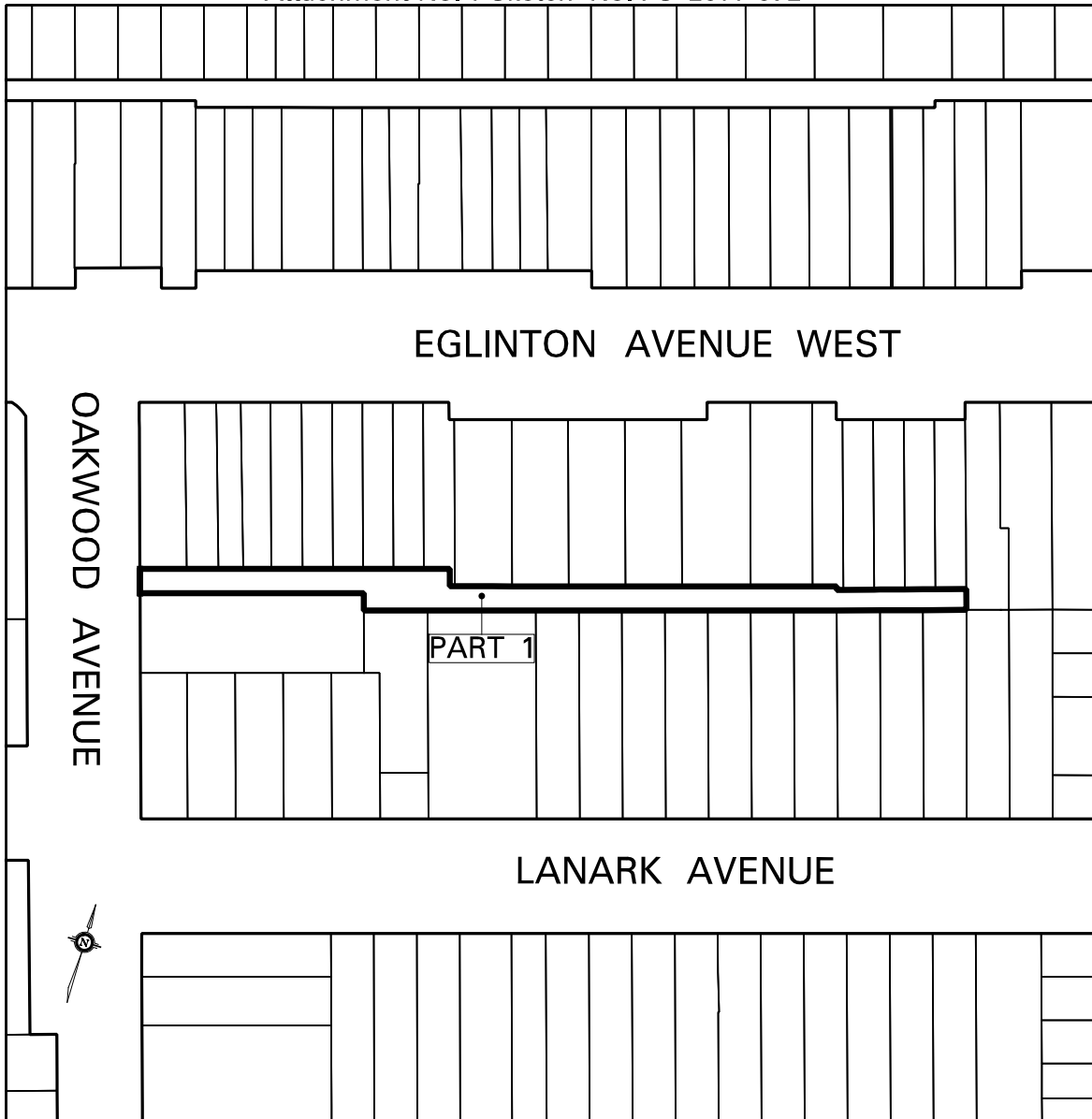
