To amend City of Toronto Municipal Code Chapter 903, Parking for Persons with Disabilities, respecting Beaconsfield Avenue, Delaware Avenue, Gladstone Avenue, Macklem Avenue, Rainsford Road, St. Patrick Street, Tyrrel Avenue and Woodgreen Place.

The Toronto and East York Community Council enacts:

- **1.** Municipal Code Chapter 903, Parking for Persons with Disabilities, is amended as follows:
