## **CITY OF TORONTO**

### **BY-LAW No. 872-2014**

#### **To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Brunel Court, Capreol Court, Dan Leckie Way, Fort York Boulevard, Housey Street and Telegram Mews.**

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Dan Leckie Way	East	Fort York Boulevard and a point 110 metres south	Anytime
Dan Leckie Way	West	Fort York Boulevard and a point 41 metres south	Anytime
Fort York Boulevard	North	A point 55 metres east of Dan Leckie Way and a point 20 metres further east	12:00 a.m. to 6:00 a.m.

B. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Dan Leckie Way	East	A point 110 metres south of Fort York Boulevard and Lake Shore Boulevard West	Anytime
Dan Leckie Way	West	Housey Street and Lake Shore Boulevard West	Anytime
Fort York Boulevard	North	Bathurst Street and a point 55 metres east of Dan Leckie Way	Anytime

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Fort York Boulevard	South	Bathurst Street and a point 75 metres east of Dan Leckie Way	Anytime

C. By inserting in Schedule XXVII (Compulsory Stops) in § 950-1326, the following in alphabetical order by street name:

(In Column 1 Intersection)	(In Column 2 Stop Street or Highway)
Capreol Court and Fort York Boulevard	Capreol Court
Dan Leckie Way and Fort York Boulevard	Dan Leckie Way
Fort York Boulevard and Capreol Court	Fort York Boulevard
Fort York Boulevard and Dan Leckie Way	Fort York Boulevard
Fort York Boulevard and Telegram Mews/Brunel Court	Fort York Boulevard
Housey Street and Dan Leckie Way	Housey Street
Telegram Mews and Fort York Boulevard/Brunel Court	Telegram Mews (southbound)
