BY-LAW No. 981-2014

To amend City of Toronto Municipal Code Chapter 694, Signs, General, Schedule B, to implement an area specific amendment with respect to a portion of the Oakville Subdivision to allow the display of fourteen topiary signs.

Whereas under sections 7 and 8 of the *City of Toronto Act, 2006* (the "*Act*"), the City may pass by-laws in respect of the health, safety and well-being of persons and the economic, social and environmental well-being of the City; and

Whereas authority is given to Council to pass by-laws respecting matters related to Structures, including fences and signs under subsection 8(2) of the Act; and

Whereas subsection 8(1) of the Act provides the City with broad authority to provide any service or thing the City considers necessary or desirable for the public; and

Whereas the City provides the regulation of signs to the citizens of Toronto as a necessary and desirable service; and

Whereas Council has authorized regulations that promote the public's ability to utilize signs to express messages, while ensuring signs are appropriate to their function and compatible with their surroundings; and

Whereas at its meeting of February 22 and 23, 2010, City Council adopted By-law No. 196-2010, which by-law enacted Chapter 694, Signs, General, to The City of Toronto Municipal Code; and

Whereas § 694-5E of Chapter 694, Signs, General, requires that a proposed sign comply with the regulations established in the provisions of the chapter prior to the issuance; and

Whereas § 694-31A of Chapter 694, Signs, General, permits a person to obtain an amendment to the provisions of the chapter with respect to a specific premises or area to establish specific regulations concerning the location, arrangement, type and design of signs to be erected within specific locations to ensure the signs displayed are appropriate to their function and compatible with the nature of the specific premises upon which the signs are located; and

Whereas § 694-31A of Chapter 694, Signs, General, permits a person to obtain an amendment to the provisions of the chapter for the purpose of permitting the erection and display of a sign which would not comply with §§ 694-15, 694-16, 694 17, 694-19 or 694-23 of Article III or Articles I, II, IV, V, VI and VII of Chapter 694; and

Whereas Council has decided that, due to the longstanding historic use of the portion of Oakville Subdivision bounded by Roncesvalles Avenue and Jameson Avenue for the display of topiary signs, and specific nature of the Oakville Subdivision as a rail corridor, an area specific amendment to permit the erection and display of 14 topiary signs in this portion of the Oakville Subdivision is appropriate; and Whereas notice of the intention to enact this by-law has been provided in accordance with the *Act* and its regulations;

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 694, Signs, General, is amended by adding Schedule "1" to this by-law as Subsection 2X to Schedule, Signage Master Plans and Area Specific Amendments.

SCHEDULE "1"

- X. Oakville Subdivision Notwithstanding, §§ 694-18C, 694-22A, B and D, but subject to all other provisions of this chapter, the specific portion of the premises defined as the Oakville Subdivision delineated with heavy lines on the diagram indicated at Subsection X(15) may contain, in addition to those signs permitted in a U-Utility sign district provided for in §§ 694-21G, and 694-25C, the following signs:

 - (f) The sign shall not be less than 20.0 metres from another sign located within the portion of the Oakville Subdivision as delineated with heavy lines on the diagram indicated at Subsection X(15);
 - (g) The sign shall only:
 - [1] Display third party sign copy consisting of the logo, corporate symbol, insignia, or motto of a business, hospital, charitable, cultural or community organizations, provincial, municipal or civic organizations, the City of Toronto's special purpose bodies, agencies, boards, commissions and corporations; or
 - [2] Non-commercial messaging; or
 - [3] Sign copy consisting of the logo or corporate symbol of the registered owner of portion of the Oakville Subdivision delineated with heavy lines on the diagram indicated at Subsection X(15);
 - (h) The sign shall not display more than 2 messages;

- (i) The sign shall not be within 0.3 metres of the northern boundary of the Oakville Subdivision, nor within 24.0 metres of southern boundary of the Oakville Subdivision;
- (j) The sign shall be erected and displayed entirely within the portion of the Oakville Subdivision labelled as Map 1 on the diagram indicated at Subsection X(16); and
- (k) The sign shall be erected and displayed entirely within the location labelled as Zone 1 on the diagram titled Map 1 indicated at Subsection X(17).
- (2) A topiary sign provided:
 - (a) The sign shall only display static copy;
 - (b) The height shall not exceed 1.0 metres;
 - (c) The sign shall have no more than 1 sign face;
 - (d) The sign face area of the sign shall not exceed 116.0 square metres;
 - (e) Each sign face shall be shaped as a rectangle; and
 - [1] The sign may have a measurement for the dimension labelled as "x2" on the diagram indicated at Subsection X(17) of no more than 5.8 metres; and
 - [2] The sign may have a measurement for the dimension labelled as "y2" on the diagram indicated at Subsection X(17) of no more than 20.0 metres;
 - (f) The sign shall not be less than 20.0 metres from another sign located within the portion of the Oakville Subdivision as delineated with heavy lines on the diagram indicated at Subsection X(15);

 - (e) The sign face shall be shaped as a rectangle; and
 - [1] The sign may have a measurement for the dimension labelled as "x6" on the diagram indicated at Subsection X(19) of no more than 5.8 metres; and
 - [2] The sign may have a measurement for the dimension labelled as "y6" on the diagram indicated at Subsection X(19) of no more than 45.1 metres;
 - (f) The sign shall not be less than 20.0 metres from another sign located within the portion of the Oakville Subdivision as delineated with heavy lines on the diagram indicated at Subsection X(15);
 - (g) The sign shall only display third party sign copy consisting of logo, corporate symbol, insignia, or motto of a business, hospital, charitable, cultural or community organizations, provincial, municipal or civic organizations, the City of Toronto's special purpose bodies, agencies, boards, commissions and corporations;
 - (h) The sign shall not display more than 1 message;
 - The sign shall not be within 3.0 metres of the northern boundary of the Oakville Subdivision, nor within 24.0 metres of the southern boundary of the Oakville Subdivision;

 - [ii] The sign may have a measurement for the dimension labelled as "y8" on the diagram indicated at Subsection X(20) of no more than 45.1 metres;
- (d) The sign may contain a landscape element provided:

 - [1] The sign may have a measurement for the dimension labelled as "x14" on the diagram indicated at Subsection X(23) of no more than 5.8 metres; and
 - [2] The sign may have a measurement for the dimension labelled as "y14" on the diagram indicated at Subsection X(23) of no more than 26.0 metres;
 - (c) The sign shall not be less than 20.0 metres from another sign located within the portion of the Oakville Subdivision as delineated with heavy lines on the diagram indicated at Subsection X(15);
 - (d) The sign shall only:
 - [1] Display third party sign copy consisting of the logo, corporate symbol, insignia, or motto of a business, hospital, charitable, cultural or community organizations, provincial, municipal or civic organizations, the City of Toronto's special purpose bodies, agencies, boards, commissions and corporations; or
 - [2] Non-commercial messaging; or
 - [3] Sign copy consisting of the logo or corporate symbol of the registered owner of portion of the Oakville Subdivision delineated with heavy lines on the diagram indicated at Subsection X(15);
 - (e) The sign shall not display more than 2 messages;
 - (f) The sign shall not be within 3.0 metres of the northern boundary of the Oakville Subdivision, nor within 24.0 metres of southern boundary of the Oakville Subdivision;

- (g) The sign is entirely located within the portion of the Oakville Subdivision labelled as Map 7 on the diagram indicated at Subsection X(16); and
- (h) The sign is erected and displayed within in the location labelled as Zone 14 on the diagram titled Map 7 indicated at Subsection X(23).
