BY-LAW No. 992-2014

To amend City of Toronto Municipal Code Chapter 925, Permit Parking, respecting Clifton Road.

As City of Toronto Council on December 4, 5 and 6, 2001 adopted Clause No. 33 of Report 9 of the Toronto East York Community Council entitled "Extension of Permit Parking Hours - Clifton Road, between St. Clair Avenue East and Glenrose Avenue (Toronto Centre-Rosedale, Ward 27) " and on December 6, 2001 enacted By-law No. 1029-2001 in connection with same; and

As Section 1, Part A of By-law No. 1029-2001 incorrectly amended Schedule XXVI (Permit Parking) in the former City of Toronto Municipal Code Chapter 400, Traffic and Parking, by inserting entries in effect from 12:01 a.m. to 10:00 a.m. on both sides of Clifton Road, from St. Clair Avenue West to Glenrose Avenue, instead of from St. Clair Avenue East to Glenrose Avenue; and

As By-law No. 1029-2001 should have but did not also rescind the permit parking entries previously enacted by City Council on June 1, 2001 under Downtown Community Council Report No. 4, Clause No. 56 and related By-law No. 483-2001 with respect to permit parking in effect from 12:01 a.m. to 7:00 a.m. on both sides of Clifton Road, from St. Clair Avenue West to Glenrose Avenue; and

As Municipal Code Chapter 925, Permit Parking, Schedule A, a harmonization/consolidation of City of Toronto permit parking By-laws/Codes enacted by City Council on September 27, 2006 under By-law No. 1067-2006, carried forward the above-mentioned errors; and

As under Section 169-26 of Municipal Chapter 169, Officials, City, the City Solicitor, in consultation with the City Clerk, may submit bills directly to make technical amendments to The City of Toronto Municipal Code and other by-laws to correct technical errors;

The Council of the City of Toronto enacts:

- 1. Municipal Code Chapter 925, Permit Parking, is amended as follows:
